Whereas, Skill Development Department, vide letter No. DSD-Gen/214/2021-02 SD(86363) dated 13.03.2023 referred One post (OM: 01) of Lecturer-I Architect Assistantship, in Skill Development Department to the J&K Public Service Commission, for selection of suitable candidate. The post was advertised vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023; *and*,

Whereas, written test was conducted on 15.09.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/79 dated: 20.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; *and*,

Whereas, Five (05) candidates were shortlisted for interview against Notification dated 26.05.2023. All 05 candidates appeared in the interview. Moreover in respect of one candidate namely Rahul Hans (Rollno: 7100008) with higher qualification of Master's of planning (Regional Planning) from School of Planning and Architecture New Delhi the same has not been considered by the Commission for providing weightage to such Higher Qualification; *and*,

Whereas, the viva-voce of candidates was conducted on 24th of March, 2025 with the assistance of Experts from outside the UT of J&K.

Whereas, upon tabulation of the points obtained in written test, interview and other attributes, it was found that none of the candidates crossed the benchmark envisaged in Rule 50 of J&K Public Service Commission (Business & Procedure) Rules, 2021.

Now, therefore, as a consequence of the facts and circumstances detailed here-in-above, the provisional Select list cannot be drawn and issued against the post. The merit of the candidates who appeard in the interview is enclosed as **Annexure-"A** to this Notification.
