Whereas, the Health and Medical Education Department, vide communication No. ME-Gztd /21 2022 (e -office) dated 07.07.2022 among others, referred 02 posts (OM=02) of Lecturer (Prosthodontics), in Government Dental College, Srinagar to the J&K Public Service Commission for being filled up through direct recruitment amongst the eligible candidates; and

Whereas the J&K Public Service Commission, vide Notification No 28-PSC(DR-P) of 2023 dated.08-06-2023, invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification; and

Whereas, the written test for these posts was conducted on 11.10.2024, the result of which was declared vide Notification No.PSC/Exam/S/2025/11 dated 05.03.2025

Whereas, upon scrutiny of the application forms, of the provisionally selected candidates it has been found that Dr. Talib Amin Naqash has submitted experience certificate from College of Dentistry King Khalid University Abha, Kingdom of Saudi Arabia.
