Whereas, Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred **Three (03) posts (OM: 01, RBA: 01, SC: 01) of Librarian**, to the J&K Public Service Commission for selection, and the Commission vide Notification No. 11-PSC (DR-P) OF 2023 dated: 05.04.2023 advertised the said posts; **and,**

Whereas, written test was conducted on 09.06.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2025/05 dated: 25.01.2025 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; **and,**

Whereas, Fifteen (15) candidates were shortlisted for viva-voce, which was conducted from 09th to 11th April, 2025 with the assistance of Experts from outside the UT of J&K. One candidate absented himself from the Interview.


Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.


