Whereas the said postS were advertised vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023. The cut-off date for determination of eligibility was fixed as 29.06.2023; **and,**

Whereas, written test was conducted on 15.09.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/79 dated: 20.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, 30 candidates were shortlisted for interview, out of which 27 candidates appeared in the Interview; **and,**

Whereas the viva-voce of candidates was conducted on 23.04.2025 and 24.04.2025, with the assistance of Experts from outside of UT.




