- 1. Whereas, the J&K Public Service Commission conducted the Written Test for filling up of posts of Physical Training Instructor/PTI (HED & GCET) in Higher Education Department, on 17.03.2024; and
- 2. Whereas, the Provisional Answer Key was notified and uploaded on the official website of the Commission for information of the candidates on 18.03.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer an objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification, i.e. upto 22.03.2024 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
- 3. Whereas, in response to the said notification, objections were received by the J&K Public Service Commission against Provisional Answer Key issued; and
- 4. Whereas, all the objections were referred to the Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Expert opinion; and
- 5. Whereas, the Experts have recommended changes in the Provisional Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-



a) The changes recommended by the Experts are hereby adopted and the Final Answer Key is annexed to this notification as Annexure A in respect of Physical Training Instructor/PTI (HED & GCET). In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules. 2022 as amended upto date, the marks allocated to the deleted questions shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged, at the time of calculation/compilation of award sheet before the declaration of the result;

b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
