Whereas the Skill Development Department, vide letter No, DSD-GEN/2014/2021-02-SD dated:13.03.2023, referred two posts (02) of Lecturer-II (Non Engineering) Medical Lab Technology, under Open (01) and ST (01) categories, to the J&K Public Service Commission, for selection of suitable candidate; *and*,

Whereas the said posts were advertised vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023. The cut-off date for determination of eligibility was fixed as 29.06.2023; **and**,

Whereas, written test was conducted on 17.09.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/79 dated: 20.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; *and*,

Whereas, 11 candidates were shortlisted for interview and all 11 candidates appeared in the Interview; *and*,

Whereas the viva-voce of candidates was conducted on 25.04.2025, with the assistance of Experts from outside of UT.

Now, therefore, on the basis of performance in the written test, interview, and other related parameters in pursuance of Rule 43 (i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

Consequent upon the details stated here-in-above, the provisional **Select List** for the posts of Lecturer-II (Non Engineering) Medical Lab Technology in Skill Development Department is given in **Annexure-B** to this Notification.
