Whereas, the Health & Medical Education Department, vide letter ME-Gztd/72/2023 dated 03.03.2023, referred (01) post of Lecturer, Periodontics, in Indra Gandhi Government Dental College, Jammu, under Open Merit Category, to the J&K Public Service Commission for selection. The posts was advertised vide Notification No. 21-PSC (DR-P) of 2023 dated 26.05.2023; and,

Whereas, the written test was conducted on 11.10.2024 and the result thereof was declared vide Notification No. PSC/Exam/S/2025/11 dated 05.03.2025. The viva-voce of the candidates was conducted on 21.04.2025, with the assistance of Experts; and,

Whereas, the Commission vide Notification No. 60-PSC (DR-S) of 2025 dated 21.04.2025 notified the Provisional Select List with a stipulation that Select List is provisional, subject to objections, if any, which were to be received within 05 days; and,


Whereas, in response to the said Notification, one representation has been received from Dr. Prabhati Gupta (Roll No. 6600008); and,

Whereas, the objection raised in the representation has been examined in the Commission and the consideration/disposal is given here under:-

	Objections	Remarks/Disposal
i.	That the points for written test, viva-voce and experience have been awarded but the points of special attributes i.e. Paper Publications and Books have not been awarded, despite submitting all the required details and proof as per Rule 44(ii) of the J&K PSC (Business and Procedure) Rules, 2021, up to 2 points should be given for research papers (0.5 points per paper, maximum 4 papers).	(i-iii) As per records, the candidate has submitted 07 publications out of which 06 have been accepted. As per rules, maximum number of publications admissible are 04, as such 02 points @ 0.50 have been awarded. The candidate has submitted one Paper Presentation which has been accepted and 0.25 points @ 0.25 per Paper Presentation has been awarded. The candidate has also submitted 02 books, both have been accepted and 01 point @ 0.50 per book has been awarded. As such the claim has no merit.
ii.	That she had submitted 7 research papers at the time of the interview, all fulfilling the required criteria (indexed journals, impact factor, author position). However, no marks	

	have been awarded for these publications.	
iii.	That, 1 point (0.5 per book, maximum 2 books) should be given for writing subject-related books as 1st or 2nd author with ISBN/ISSN, and she had submitted 2 books with all required documents during the interview. But again, no marks were given for these books.	

Now, therefore, the representation is hereby rejected, being devoid of any merit.
