Whereas, the Health & Medical Education Department, vide letter ME-Gztd/72/2023 dated 03.03.2023, referred (01) post of Lecturer, Pedodontics, in Government Dental College, Srinagar under Open Merit Category, to the J&K Public Service Commission for selection. The posts were advertised vide Notification No. 21-PSC (DR-P) of 2023 dated 26.05.2023; and,

Whereas, the written test was conducted on 11.10.2024 and the result thereof was declared vide Notification No. PSC/Exam/S/2025/11 dated 05.03.2025. The viva-voce of the candidates was conducted on 22.04.2025, with the assistance of Experts; and,

Whereas, the Commission, vide Notification No. 62-PSC (DR-S) of 2025 dated 22.04.2025 notified the Provisional Select List with a stipulation that Select List is provisional subject to objections, if any, which were to be received within 05 days; and,

Whereas, in response to the said Notification, one representation has been received from Dr. Mohamad Arshid Khanday (Roll No. 6300004); and,

Whereas, the objection raised in the representation was examined in the Commission and the consideration/disposal is given here under:-

Objections	Remarks/Disposal
Aggrieved with the revised answer for question 84 in series "A", which was changed to option C from option B, and has sought re-verification.	After receiving the objections regarding the correct option of Q. No. 84, further action was initiated under rule 10 (d) of J&K PSC (Conduct of Examinations) Rules, 2022. Thereafter the final answer key was finalized under Rule 10 (f) of J&K PSC (Conduct of Examinations) Rules, 2022 and result was declared. As such the claim has no merit.
One of the books submitted by the candidate is related to her library dissertation during PG and needs reassessment.	The claim is without any evidence and based on presumptions.
The scientific publications and studies submitted by the candidate are based on forged studies as there is no mention of guide, HOD, or any other staff as Co-author and needs re-verification.	The claim is without any evidence and based on presumptions

Now, therefore, the representation is hereby rejected, being devoid of any merit.
