Whereas, Forest, Ecology & Environment Department, vide letter No. FST-GAZ/4/2022-02-ForestDeptt Dated: 05.04.2022, referred **Three (03) posts (OM: 01, RBA: 01, SC: 01) of Scientific Assistant, in Forest, Ecology & Environment Department**, to the J&K Public Service Commission, for selection of candidates and Commission, vide Notification No. 25-PSC (DR-P) of 2022 dated 31.10.2022, advertised the said posts for selection; *and,*

Whereas, written test was conducted on 29.08.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/69 dated: 05.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; *and,*

Whereas, seventeen (17) candidates were shortlisted against Notification dated 31.10.2022. The candidature of 01 candidate was rejected and 16 candidates were called for interview. All 16 candidates appeared in the interview; *and,*

Whereas, the viva-voce of candidates was conducted on 17th June, 2025 with the assistance of Experts from outside the UT of J&K.

Now, therefore, on the basis of the performance in the written test & interview, the merit of the candidates who appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the details given here-in-above, Provisional Select List of the candidates for the post of Scientific Assistant, in Forest, Ecology & Environment Department, as per merit, is given in **Annexure-B** to this Notification.
