Whereas, the Health & Medical Education Department, vide letter ME-Gztd/21/2022 dated 07.07.2022, referred (02) posts of Lecturer, Prosthodontics including Dental Material, Government Dental College, Srinagar and (01) post of Lecturer, Prosthodontics including Indra Gandhi Government Dental College, Jammu, under Open Merit Category, to the J&K Public Service Commission for selection. The posts was advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023; and,

Whereas, the written test was conducted on 11.10.2024 and the result thereof was declared vide Notification No. PSC/Exam/S/2025/11 dated 05.03.2025. The viva-voce of the candidates was conducted on 23.05.2025, with the assistance of Experts; and,

Whereas, the Commission vide Notification No. 67-PSC (DR-S) of 2025 dated 26.05.2025 notified the Provisional Select List with a stipulation that Select List is provisional, subject to objections, if any, which were to be received within 05 days; and,


Whereas, in response to the said Notification, one representation has been received from Dr. Mohammad Arif Lone (Roll No. 6700005); and,

Whereas, the objection raised in the representation and the consideration/disposal is given here under:-

Objection	Remarks/Disposal
<p>The candidate is aggrieved with the following:</p> <p>That 21 questions with question number as follows:- 1, 2, 3, 4, 5, 17, 20, 21, 24, 26, 27, 29, 31, 32, 33, 34, 35, 36, 41, 49, 50 have been directly copied word to word (not even modified) from the question papers of Odisha Public Service Commission. Where MCQ No. 26 was from different specialty and was copied too.</p> <p>Further, question paper of J&K, PSC & Odisha PSC already submitted via mail over time on the official address, was marked by competent authority in JKPSM to the concerned Examination Section.</p>	<p>The presence of similar or repeated questions across two different papers does not, in itself, indicate any irregularity. Question papers are prepared by subject matter experts who exercise professional discretion in designing assessments. It is within their legitimate purview to include questions they deem appropriate for effectively evaluating the required knowledge & skill test.</p>


Even after being called for interview a request was made that written examination should be cancelled and fresh exam should be conducted but instead viva voce was held keeping aside every representation that was submitted.
