Subject: Filling up of the posts of Assistant Director (E&S), in J&K, Planning Development & Monitoring Department-rejection of candidature thereof.

## Notice Dated: 03.07.2025

Whereas, Planning Development & Monitoring Department, vide letter No. PD-HRM/38/2022 dated 10.01.2023, referred 09 posts (OM=05, RBA=01, SC=01, ST=01, EWS=01) of Assistant Director (E&S) in J&K Planning Development & Monitoring Department to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised, vide Notification(s) No. 13-PSC (DR-P) of 2023 dated 13.04.2023; and,

Whereas, Planning Development & Monitoring Department, vide letter No. PD-HRM/38/2022 dated 21.02.2024, again referred 89 posts (OM=44, RBA=08, SC=07, ST=09, EWS=09, PSP=04, ALC/IB=04, SoC=04) of Assistant Director (E&S) in J&K Planning Development & Monitoring Department to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised, vide Notification(s) No. 01-PSC (DR-P) of 2024 dated 05.03.2024.

Whereas, the written test was conducted w.e.f 06.08.2024 to 21.08.2024, and the result thereof was declared vide Notification No. PSC/Exam/S/2025/06 dated 31.01.2025; and,

Whereas, upon scrutiny of the documents, it was found that the following candidates have not submitted the valid documents. Accordingly, vide Notice dated 15.05.2025, these candidates were advised to submit the documents, as indicated against each:-

Whereas, further scrutiny of the documents submitted by the above candidates in repose to the Notice dated 15.05.2025, revealed that :-

- The category certificate of Ms. Rashi Chib, Mr. Sandeep Singh and Mr. i. Vishal Gupta, are not as per the prescribed format.
- The result of Mr. Ashfaq Ahmad has been declared after the cut of date ii. of the advertisement Notification.
- iii. The EWS category certificate of candidate falling in the consideration zone, namely, Ms. Rozi Chowdhary, Roll No. 7104269, has been issued on Central Format.

Now, therefore, the candidature of (i) Ms. Rashi Chib (ii) Mr. Sandeep Singh (iii) Mr. Vishal Gupta (iv) Mr. Ashfaq Ahmad, and (v) Ms. Rozi Chowdhary is hereby rejected. However, if any of the candidate(s) feel aggrieved with the rejection of his/her candidature, he/she may represent before the Appellate Authority of the Commission with documentary evidence in support of his/her claim within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period is over.
