Subject: Filling up of the post of Lecturer-II (Non-Engineering) Garment Technology in Skill Development Department-Rejection of candidature thereof.

Whereas, the Department of Skill Development vide letter No. DSD-Gen/214/2021-02-SD(86363) dated 13.03.2023, among others, referred (01) post, under SC category of Lecturer-II (Non-Engineering) Garment Technology in Skill Development Department, to the J&K Public Service Commission for selection; and,

Whereas, the said post was advertised, vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023, and

Whereas, the prescribed qualification for the post of Lecturer II (Non-Engineering) Garment Technology in Skill Development Department is as under:-

- I. *Bachelor's Degree with 55% marks in appropriate branch / discipline or equivalent from a recognized institution / university.*
- II. *Bachelor's Degree in Arts/Science/Commerce with first class diploma in relevant discipline, from a recognized institution / University.*
- III. *Diploma Holders first class in appropriate branch / discipline from a recognized institution. Preference shall be given to the candidates from category -I, in case no candidate from this category is available then preference shall be given to the candidates from category II, in case no candidate is available from this category also then candidates from category III shall also be taken.*

Whereas, the written test was conducted on 15.09.2024 & 17.09.2024, and the result thereof was declared vide Notification No. PSC/Exam/S/2024/79 dated 20.11.2024; and,

Whereas, upon scrutiny of the documents, it has been found that the Ms. Sonia D/o Darshan Kumar, Roll No. 8000007 do not possess the requisite relevant qualification for the said post.

Now, therefore, the candidature of the above named candidate is hereby rejected. If she feels aggrieved with the rejection of her candidature, she may represent before the Appellate Authority of the Commission with evidence in support of her claim within 10 days from the date of issuance of this Notice. No claim whatsoever shall be entertained after the stipulated period.
