Filling up of the post of Assistant Professor (Nursing) in various B. Sc Nursing Colleges in Health & Medical Education Department- Decision of

the Appellate Authority thereof.

## Notice Dated: 12.08.2025

Whereas, the Health and Medical Education Department vide letter No. ME-NG/11/2021-09 dated 08.02.2023, referred ten (10) posts (OM-05 RBA-01 SC-01 ST-01 ALC/IB-01 EWS-01) of Assistant Professor (Nursing) in various B.Sc Nursing Colleges to J&K Public Service Commission for selection; and

Whereas, the posts were advertised vide Notification No. 14-PSC (DR-P) OF 2023 dated 02.05.2023; and

Whereas, the prescribed qualification for the posts of Assistant Professor (Nursing) in various B. Sc Nursing Colleges as per method of recruitment is:-

"M.Sc Nursing (Ph.D Desirable) with three years of teaching experience post M. Sc Nursing)."

Whereas, the written test was conducted on 15.09.2024 and the result thereof was declared vide Notification No.PSC/Exam/S/2024/75 dated 08.11.2024; and

Whereas, upon scrutiny of the documents, it was found that the candidates whose details are given below do not possess the requisite relevant qualification and/ or experience for the said post. Accordingly, their candidature was rejected vide Notice dated 01.07.2025, with a stipulation that if any of the candidate(s) feels aggrieved with the rejection of his/her candidature, he/she may represent before the Appellate Authority of the Commission:

Whereas, in response to the ibid Notice, all the above candidates put their claim against their rejection except one candidate, namely, Neha Sharma Roll No. 7000134 who has not responded to the Rejection Notice.

Whereas, the appeals of above said candidates were placed before the Appellate Authority of the Commission for decision with regard to their claims.

The decision of the Appellant Authority is given here under:-

1.	Mohd Suhail	The Appellate Authority is of the view that the experience

7.	Sonia Baseen	The candidate has been awarded Master's degree in the
		year 2023 and the candidate does not possess the required
		teaching experience of three years post master's degree. As
		the candidate is not having any teaching experience after
		PG, hence her appeal is devoid of any merit and is
		accordingly rejected.
8.	Irfan Bashir Wani	The candidate has worked as Part Time Nursing tutor in
		Royal Institute of Paramedical Sciences, Ganderbal. The
		candidate has not worked against any faculty position or
		tenure post, which is the basic requirement for
		consideration of experience of any candidate. Hence the
		plea of the candidate is devoid of any merit and is
		accordingly rejected.
9.	Owaise Aga	The candidate has been awarded Master's degree in the
		year 2023 and the candidate does not possess the required
		teaching experience of three years post master's degree.
		Although the candidate has more than three years of
		experience as Staff Nurse in SKIMS but this experience is
		not relevant for the post as the same is clinical experience.
		The candidate is not having any teaching experience after
		PG, hence her appeal is devoid of any merit and is
		accordingly rejected.
10.	Gulfam Koser	The date of result of Masters degree of the candidate is 10-
		12-2021. The candidate has worked in AMT School, Poonch
		as Public Health Nurse for more than nine years including
		PG period. Major part of the experience of the candidate is



		pre-PG and her experience after PG is less then three years. The candidate is not fulfilling the basic eligibility condition of three years teaching experience after PG. As such, the plea of the candidate is devoid of any merit and is accordingly rejected.
11.	Monika Devi	It has been found that the candidate has total experience of one year and 08 months after post-graduation. The pleas of the appellant to consider her work as Junior Staff Nurse in Govt. AMT School, Jammu, as teaching experience, is not justified, as Staff Nurse is purely clinical job and cannot be treated as teaching experience. As such, the appellant is not fulfilling the basic eligibility condition of three years teaching experience after post graduation. Hence the pleas of the candidate is devoid of any merit and is accordingly rejected.
12.	Isha Chib	The case requires further examination in the Commission and shall be notified separately.
