5. Whereas, the Experts have recommended changes in the Provisional Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

- a) The changes recommended by the Experts are hereby adopted and the Final Answer Key is annexed to this notification.

b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
