Subject: Provisional Select List (Revised) for the post of Lecturer Oral & Dental Pathology, in Government Dental College, Srinagar in Health & Medical Education Department. Disposal of representation thereof.

NOTICE

Dated: 16.09.2025

Whereas, among others, 11 posts in various disciplines of Dentistry in Government Dental College, Srinagar and Indira Gandhi Government Dental College, Jammu were advertised vide Notification No 16-PSC (DR-P) dated 12.07.2022 and 21-PSC (DR-P) of 2023 dated 26.05.2023; and

Whereas, Dr. Nawal Khan filed an O.A No. 343/2025 before the Central Administrative Tribunal, Srinagar praying for the following relief:-

1. Direct the Respondents to forthwith withdraw Advertisement Notifications No. 16-PSC (DR-P) of 2022 and 21-PSC (DR-P) of 2023, insofar as they pertain to the post of Lecturer in Government Dental College, Srinagar, dated 26-05-2025 in view of the implementation of the 3-tier recruitment structure dated 30-01-2025.
2. Direct the Respondents to initiate a fresh recruitment process for the post of Assistant Professor in accordance with Government Order No. 85-JK (HME) of 2025 dated 30.01.2025.
3. Declare the inaction of the Respondents in not withdrawing the notifications concerning GDC Srinagar as discriminatory, arbitrary, and violative of Articles 14 and 16 of the Constitution of India.
4. Pass such other and further orders as this Hon'ble Tribunal may deem just and proper in the interest of justice.
5. To stay the recruitment process or in alternative consider the detailed representation submitted by the applicants and till the same is done, not to proceed with the recruitment process initiated vide Advertisement Notifications No. 16-PSC (DR-P) of 2022 and 21-PSC (DR-P) of 2023.

Whereas, the Central Administrative Tribunal, Srinagar vide Order dated 21.04.2025 passed the following directions:

"respondent are directed to dispose of the representations filed by the petitioners in accordance with law and the observations made in the order. It is also ordered that though this court would not halt the process of selection, but the Public Service Commission shall not declare the results in the discipline of oral pathology, till the representations of the petitioners are disposed of in accordance with


law and the merits. It is expected that the needful will be done within a period of two weeks. Learned counsel representing the Public Service Commission to keep the Registry of this court aware about the disposal of the representations filed by the petitioner."

Whereas, the representation dated 19.02.2025 put forth by the applicant and others, has been examined and it has been found that Health & Medical Education Department vide letter No. HME-Acct/106/2021-02 (CC:27139) dated 25.06.2024 requested the J&K Public Service Commission that the posts of Lecturer of various discipline in Government Medical College/Super Specialty Hospital Srinagar and Government Medical College/Super Specialty Hospital Jammu referred to the Commission from time to time shall be deemed to have been withdrawn ab-initio in view of the implementation of the 3-Tier faculty structure in Government Medical College/Super Specialty Hospital Srinagar and Government Medical College/Super Specialty Hospital Jammu on the pattern of 07 New Government Medical Colleges of UT of Jammu & Kashmir, as per norms of National Medical Council (NMC); and

Whereas, no such communication regarding the posts of Dentistry in Government Dental College Srinagar/Indira Gandhi Government Dental College, Jammu referred to the Commission, was received from the Health & Medical Education Department; and

Whereas, the Commission, therefore, proceeded with the selection of posts for Government Dental College, Srinagar and Indira Gandhi Government Dental College, Jammu advertised vide Notification No. 16-PSC (DR-P) dated 12.07.2022 and 21-PSC (DR-P) of 2023 dated 26.05.2023.

Now, therefore, the claim of the applicant having been examined in light of the Order dated 21.04.2025 passed by Hon'ble Central Administrative Tribunal, Srinagar, in O.A No 343/2025 has been found devoid of any merit and is, hence, rejected.
