Subject: Provisional Select List for the post of Deputy Medical Superintendent, in Government Medical College Srinagar & Jammu in Health & Medical Education Department.

Notification No. 70-PSC (DR-S) of 2025 Dated: 17.09.2025

Whereas, the Health & Medical Education Department, vide letter No, MEGZTD/246/2022 E-Office dated 15.12.2022, referred five (05) posts of Deputy Medical Superintendent, (OM-02, ST-01 GMC Srinagar) (RBA-01, SC-01 GMC Jammu), to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the posts were advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; *and*,

Whereas, again, the Department vide letter No. ME-Gztd/246/2022 (CC: 7037074) dated 30.10.2023, referred two (02) posts (OM-01 GMC Srinagar & OM-01 GMC Jammu), to the J&K Public Service Commission, for selection of suitable candidates; *and*,

Whereas, the posts were advertised vide Notification No. 40-PSC (DR-P) of 2023 dated 07.11.2023. The cut-off date for determination of eligibility was fixed as 27.11.2023; **and**,

Whereas, a written test was conducted on 17.03.2024. The result of the written test was declared vide Notification No.PSC/Exam/S/2024/12 dated: 03.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; *and*,

Whereas, **04** candidates were called for interview against Notification No. 31-PSC of 2022 & 06 candidates were called for interview against Notification No. 40-PSC of 2023. Since some candidates had applied & were shortlisted against more than one notification as per their merit, as such only 07 candidates were called for interview. No candidate remained absent; **and**,

Whereas, the viva-voce of candidates was conducted on 09.09.2024, with the assistance of Experts from outside of UT.



Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure-A** to this Notification.

Consequent upon the details given here-in-above, the candidates whose particulars are given as **Annexure-B** to this Notification, are provisionally selected against the following posts:-
