Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, among others, referred 04 posts (OM=02, RBA=01, SC=01) of Associate Professor (Architecture) in the School of Architecture in Higher Education Department, to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised vide Notification No. 15-PSC (DR-P) of 2023 dated 02.05.2023; and,

Whereas, the written test was conducted on 22.10.2023 and 04 candidates were declared to have qualified the written test vide Notification No. PSC/Exam/S/2024/06 dated 27.03.2024; and,

Whereas, upon scrutiny of the documents, it has been found that the following candidates have deficiency in respect of the documents, accordingly vide Notice dated 07.08.2025 they were advised to get the documents authenticated/countersigned by the designated authorities as envisaged in Rule-45 of J&K Public Service Commission (Business & Procedure) Rule-2021 :-

Whereas, in response to ibid Notice, only Ms. Charu Kapoor and Deepika Gupta has submitted documents, Mr. Qazi Qamar Iqbal has not responded to the said Notice; and,

Whereas, the documents submitted by Ms. Charu Kapoor and Ms. Deepika Gupta were again scrutinized and it has been found that both the candidates does not possess the requisite relevant experience for the said post.

Now, therefore, the candidature of Ms. Charu Kapoor, Roll No. 3100019 Ms. Deepika Gupta Roll No. 3100022, and Mr. Qazi Qamar Iqbal Roll No. 3100002 is hereby rejected. If the candidates feel aggrieved with the rejection of his/her candidature, he/she may represent before the Appellate Authority of the Commission, with evidence in support of his/her claim within 10 days from the date of issuance of this Notice. No claim whatsoever shall be entertained after the stipulated period.
