- 5. Whereas, the Experts have recommended **No change** in the Provisional Answer Key(s) in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that the recommendations of the Experts are hereby adopted and the Final Answer Keys are annexed to this notification as "Annexure A and Annexure B" in respect of Paper-I and Paper-II.
