Whereas, the Department of Skill Development vide letter No. DSD-Gen/2014/2021-02-SD dated 13.03.2023, among others, referred (03) posts (OM=02, ST=01) of Lecturer-I Electrical Engineering in Skill Development Department, to the J&K Public Service Commission for selection; and,

Whereas, the said posts were advertised, vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023, and

Whereas, the written test was conducted on 15.09.2024, the result thereof was declared vide Notification No. PSC/Exam/S/2024/79 dated 20.11.2024; and,

Whereas, the Commission, vide Notification No 71- PSC(DR-S) of 2025 dated 22.09.2025, notified the Provisional Select List with a stipulation that the select list is provisional subject to objections, if any, received within five days from the date of notification; and,

Whereas, One representation from Mr. Khalid Mehmood has been received against one provisionally selected candidate, wherein it was alleged that out of 04 candidates called in interview under ST category one under Roll no 7400256 namely Mohd Hilal Choudhary was provisionally selected by J&K PSC as lecturer-1 in Electrical Engineering. Mr. Mohd Hilal Choudhary has completed his degree in (Electrical and Electronics Engineering) which is totally against the advertisement notification and norms. The Electrical and Electronics Engineering is a separate Branch and there is no mention of this degree anywhere in advertisement notification issued by PSC.

Whereas, the matter was deliberated upon and it was found that the selected candidate, namely, Mohd Hilal Choudhary under ST category has B. Tech in Electrical Engineering from IIT Patna which is as per prescribed qualification i.e., Bachelors degree in Engineering/Technology/Disciplines in appropriate branch of Engineering.

Now, therefore, the representation is disposed of, being devoid of any

merit, and is rejected.
