1. Whereas, the J&K Public Service Commission conducted the Written Test for filling up of posts of Maternity & Child Welfare Officer cum Lecturer/AP, Maternity & Child Welfare Officer (Ancillary Staff), Antenatal Care Incharge (Ancillary Staff), Antenatal Medical Officer Cum Lecturer, Assistant Professor (Obsts. & Gynae), Assistant Professor (Anesthesiology), Assistant Professor (General Medicine), Assistant Professor (General Surgery), Rural Training Health Centre, Rural Training Health Centre (Medical Officer Health cum Lecturer), Medical Officer Health cum Lecturer/AP (RTHC), Urban Training Health Centre, Urban Training Health Centre (Medical Officer Health cum Lecturer) in Health and Medical Education Department, on **07.10.2025** and **08.10.2025**; and
2. Whereas, the Provisional answer key(s) were notified and uploaded on the official website of the Commission for information of the candidates on **07.10.2025** and **08.10.2025**, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of notifications along with documentary proof/evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notifications, objections were received by the J&K Public Service Commission against Provisional Answer Key(s) issued in

respect of 04 disciplines viz. [Maternity & Child Welfare Officer cum Lecturer/AP/Maternity & Child Welfare Officer (Ancillary Staff)/ Antenatal Care Incharge (Ancillary Staff)/Antenatal Medical Officer Cum Lecturer/ Assistant Professor (Obsts. & Gynae)], Anesthesiology, General Medicine and General Surgery. **However, no objections have been received in respect of 02 disciplines viz.** Rural Training Health Centre/ Rural Training Health Centre (Medical Officer Health cum Lecturer)/Medical Officer Health cum Lecturer/AP(RTHC) and Urban Training Health Centre/Urban Training Health Centre (Medical Officer Health cum Lecturer); and

4. Whereas, all the objections were referred to the Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Expert opinion; and
5. Whereas, the Experts have recommended changes in the Provisional Answer Key(s) in respect of the said paper(s);

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

- a) The changes recommended by the Experts are hereby adopted and the Final Answer Key(s) are annexed to this notification as **Annexure A, B, C, D, E and F** in respect of [Maternity & Child Welfare Officer cum Lecturer/AP/ Maternity & Child Welfare Officer (Ancillary Staff)/ Antenatal Care Incharge (Ancillary Staff)/ Antenatal Medical Officer Cum Lecturer/ Assistant Professor (Obsts. & Gynae)], Anesthesiology, General Medicine, General Surgery, Rural Training Health Centre/ Rural Training Health Centre (Medical Officer Health cum Lecturer)/ Medical Officer Health cum Lecturer/AP(RTHC) and Urban Training Health Centre/Urban Training Health Centre (Medical Officer Health cum Lecturer) in Health and Medical Education Department respectively. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions ***shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged,*** at the time of calculation/compilation of award sheet before the declaration of the result;

- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
