- Whereas, the J&K Public Service Commission conducted the Written Test for filling up of post(s) of Lecturer (Geography) in the School Education Department, on 27.09.2025; and
- 2. Whereas, the Provisional Answer Key was notified and uploaded on the official website of the Commission for information of the candidates on 27.09.2025, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer objection on the prescribed proforma to the Controller of Examinations upto 03.10.2025 (5:00 p.m.) along with documentary proof /evidence and the fee of Rs.500/- per question; and
- 3. Whereas, in response to the said notification, objections were received by the J&K Public Service Commission against Provisional Answer Key; and
- 4. Whereas, all the objections were referred to the Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Expert opinion; and
- 5. Whereas, the Experts have recommended changes in the Provisional Answer Key in respect of the said paper;



Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

a) The changes recommended by the Experts are hereby adopted and the Final Answer Key is annexed to this notification as **Annexure A** in respect of **Geography**. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions **shall be individually added to the marks secured by the individual candidates to ensure that the**

mark(s) allocated for the question paper as a whole remain unchanged, at the time of calculation/compilation of award sheet before the declaration of the result;

b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
