Whereas, the Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 24.03.2023, referred two (02) posts (OM: 01, RBA: 01) of Assistant Professor (Cost Accounting), to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the J&K Public Service Commission, vide Notification No. 17- PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 16.06.2023; **and**,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 45 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 05.11.2023, at Srinagar and Jammu; *and*,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2024/08 Dated: 01.04.2024. Ten (10) candidates were declared to have qualified for interview provisionally; *and*,

Whereas, the viva-voce of candidates was conducted on 05.12.2025, with the assistance of Expert from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
