Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred three (03) posts (OM: 02, SC: 01) of Lecturer, Dogri, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; **and,**

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/51 Dated: 12.11.2025. Fifteen (15) candidates were declared to have qualified for interview provisionally; **and,**

Whereas, the viva-voce of candidates was conducted on 23.12.2025, with the assistance of Experts.


