Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred three (03) posts (OM: 02, SC: 01) of Lecturer, Dogri, to the J&K Public Service Commission, for selection of suitable candidates; and,

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; *and*,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; *and*,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/51 Dated: 12.11.2025. Fifteen (15) candidates were declared to have qualified for interview provisionally; *and*,

Whereas, the viva-voce of candidates was conducted on 23.12.2025, with the assistance of Experts.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43,1(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
