Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred One (01) post (OM Category), of Lecturer, Punjabi, to the J&K Public Service Commission, for selection of suitable candidate; **and**,

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said post for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; *and*,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; *and*,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2025/51 Dated: 12.11.2025. Five (05) candidates were declared to have qualified for interview provisionally; *and*,

Whereas, the viva-voce of candidates was conducted on 24.12.2025, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43,1(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the facts stated here-in-above, Harsimran Singh S/O Surjeet Singh R/O H.NO-79 Upper Gadi Garh Jammu South, Jammu, having secured 70.81 points, is provisionally selected against the available post.
