Whereas, the posts were advertised, vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024; and,


Whereas, the written test was conducted on 27.09.2025, and 24 candidates were declared to have qualified written test vide Notification No. PSC/Exam/S/2025/51 dated 12.11.2025; and,

Whereas, the upper age limit for candidate belonging to OM category is 40 years as on 1<sup>st</sup> January, 2024 as per the terms & conditions of advertisement Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024; and,

Whereas, *Mr. Mohammad* Shafi Dar has applied for the post under RBA category, however, the post applied for is in OM category; and,

Whereas, the Date of Birth of Mr. Mohd Shafi Dar Roll No. 6100021, is 04.10.1982 and as on 01.01.2024 his age is 41 years, 02 months & 27 days thus ineligible for OM category.

Now, therefore, the candidature of the Mr. Mohammad Shafi Dar is hereby rejected for the post of Lecturer **Geography** in School Education Department being over-aged for OM. If the candidate feels aggrieved with the rejection of his candidature, he may represent before the Appellate Authority of the Commission through with evidence in support of his claim within 10 days from the date of issuance of this Notice.
