Whereas, Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated 13.04.2022, referred **four (04) posts, Open Merit-02, RBA-01 and SC-01** category of Associate Professor, Architecture, in School of Architecture, to the J&K Public Service Commission, for selection; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 15-PSC (DR-P) OF 2023 dated: 02.05.2023, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 04.06.2023; *and*,

Whereas, written test was conducted on 22.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/06 Dated: 27.03.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 and 45 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; *and*,

Whereas, four (04) candidates were declared to have qualified for interview provisionally. Out of (04) candidates, 03 candidates were found ineligible & only 01 candidate was declared eligible; *and*,

Whereas, the viva-voce of the candidate was conducted on 29.12.2025, with the assistance of Experts from outside of the Union Territory of J&K; *and*,

Now, therefore, on the basis of the performance in the written test and interview, Anoop Kumar Sharma S/O Sumer Nath Sharma R/O 263/A Amphalla Jail Road Opp AAstha Nursing Home having secured 58.88 points, is provisionally selected against the said post. The detailed award is given in Annexure to this Notification.
