Provisional Select List for the post of Lecturer-II (Non-Engineering) Garment Technology, in Skill Development Department.

Notification No. 82-PSC (DR-S) of 2025 Dated: 30.12.2025

Whereas, Skill Development Department, vide letter No. DSD-Gen/214/2021-02 SD(86363) dated 13.03.2023 referred one post under SC category of Lecturer-II Garment Technology, in Skill Development Department to the J&K Public Service Commission, for selection of suitable candidate. The post was advertised vide Notification No. 19-PSC (DR-P) of 2023 dated 26.05.2023; and,

Whereas, the J&K Public Service Commission, vide Notification No. 19-PSC (DR-P) OF 2023 dated: 26.05.2023, advertised the said post for inviting applications. The cut-off date for determination of eligibility was fixed as 29.06.2023; and,

Whereas, written test was conducted on 15.09.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/79 dated: 20.11.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021; and,

Whereas, four (04) candidates were declared to have qualified for interview provisionally. Out of (04) candidates, (03) candidates were declared eligible & (01) candidate was found in-eligible; *and*,

Whereas, the viva-voce of the candidates was conducted on 30.12.2025, with the assistance of Experts from outside of the Union Territory of J&K. One candidate was found ineligible by the Interview Board due to not possessing relevant qualification; and,

Whereas, upon tabulation of the points obtained in written test, interview and other attributes, it was found that none of the candidates crossed the benchmark envisaged in Rule 50 of J&K Public Service Commission (Business & Procedure) Rules, 2021.



Now, therefore, as a consequence of the facts and circumstances detailed here-in-above, the provisional Select list cannot be drawn and issued against the said post. The merit of the eligible candidates who appeared in the interview is enclosed as **Annexure** to this Notification.
