**Subject:** Cancellation of recommendation of Mr. Mohit Sasan S/o Satish Kumar for the post of Assistant Professor (Commerce) in the Higher Education Department.

Order No. *DS* of 2026

Dated: 07.01.2026

Whereas, the Higher Education Department vide letter No. HE/Coll/Coord/Appt/A.P/2021 Dated: 05.07.2021 and HED/Gaz/85/2022-04 dated 13.04.2022, referred six (06) posts of Assistant Professor, Commerce (OM 03, RBA 01, SC 01, ST 01) for selection of the suitable candidates; and,

Whereas, these posts were advertised vide Notification No: 6 - PSC(DR-P) of 2023 Dated: 01.03.2023; and,

Whereas, again the Department vide indent Dated: 24.03.2023, referred 14 more posts of AP Commerce (OM 06, SC 01, ST 01, ALC/IB 01, SLC 01, RBA 01, PSP 01, EWS 02) to the J&K Public Service Commission for selection; and,

Whereas, the Commission vide Notification No. 17 -PSC (DR - P) of 2023 Dated: 15.05.2023., advertised the above 14 posts, invited online application form from the candidates; and,

Whereas, written test for 20 posts, notified under both notifications was conducted on 10.09.2023 and results were declared vide notification No. PSC/Exam/S/2023/58 dated 05.10.2023; and,

Whereas, the interview/ Viva voce of shortlisted candidates was conducted on 12th and 13th of October of 2023 and the provisional Select List was issued vide Notification Dated: 77-PSC (DR-S) of 2023 dated 18.10.2023. The Select List was provided to Higher Education Department in respect of both the notifications vide this Commission's Letter No. PSC/DR-HE/AP-Commerce/2023 Dated: 02.11.2023; and,

Whereas, one candidate namely, Mr. Mohit Sasan S/O Satish Kumar R/O Muradpur Rajouri was recommended under PSP category with merit points 50.23, under notification No: 17-PSC (DR-P) of 2023 Dated: 15.05.2023; and

Whereas, this Commission in the meanwhile received a copy of OA No: 187/2025 titled Naveed Anjum Mir v/s UT of J & K and Ors filed before Hon'ble Central Administrative Tribunal Jammu. He stated that the Respondent No: 3 (Mohit Sasan) has obtained PSP certificate fraudulently which stands cancelled now by Deputy Commissioner Rajouri vide Order dated: 24.02.2025. Being next in merit candidate the petitioner prayed for, inter-alia, to recommend him for appointment.

Whereas, the Commission vide Letter dated 29.08.2025 approached Higher Education Department and requested in light of the OA filed, to enquire into the matter and share the report so that further necessary action can be taken on merits. Besides, it was also requested to file objections and contest the case on

behalf of the Commission, as the verification of the genuineness of the certificate falls within the domain of the indenting authority; and

Whereas, Higher Education Department in response to communication, vide Letter Dated: 09.10.2025 enclosed a copy of report furnished by Deputy Commissioner Rajouri for further course of action by the Public Service Commission. The Deputy Commissioner Rajouri in his report dated: 30.09.2025 has conveyed that the PSP certificate issued in favour of Mr. Mohit Sasan by the then Tehsildar vide No: PSPC/TR/1220 - 24 Dated: 01.02.2020, was cancelled as void ab-initio vide DC Rajouri's No: ASD/DCR/112/2023-25 Dated: 24.02.2025; and

Whereas, the Commission received an application from the applicant (Naveed Anjum Mir) alongwith copy of Government Order No. 181-JK(HE) of 2025 dated 11.4.2025 whereunder appointment of Mr. Mohit Sasan as AP Commerce which was made vide Government Order No. 88-JK(HE) of 2024 dated 22.2.2024, has been cancelled ab initio; and,

Whereas, the selection/ recommendation of Mr. Mohit Sasan S/o Satish Kumar for the post of Assistant Professor (Commerce) was made on the basis of being PSP category candidate. The PSP certificate issued to him stands cancelled as void ab-initio by Deputy Commissioner Rajouri, as such his candidature under PSP category is cancelled, hereby, ab-initio.

In view of the facts/report mentioned here-in-above, the selection/ recommendation of Mohit Sasan S/o Satish Kumar R/o C/o Mohit Sasan Muradpur Rajouri for the post of Assistant Professor (Commerce), under Notification No. 17 - PSC (DR - P) of 2023 dated: 15.05.2023 is hereby cancelled ab-initio, as not being a PSP category candidate.
