Whereas, the Health and Medical Education Department, vide letter No. Me-Gztd(20201(CC:7331789) dated 09.07.2024, among others, referred 03 posts(OM:02 & SC:01) of Assistant Professor, General Medicine in Sher-i-Kashmir Institute of Medical Sciences(SKIMS), Soura, Srinagar to the J&K Public Service Commission for selection; and,

Whereas, the posts were advertised vide Notification No. 03-PSC(DR-P) of 2025 dated 04.02.2025; and,


Whereas, the written test was conducted on 07/08.10.2025 and 10 candidates were declared to have qualified the written test vide Notification No. PSC/Exam/S/2025/53 dated 12.11.2025; and.

Whereas, vide Notice dated 19.12.2025, the candidates were advised to furnish the deficient documents; and.

Whereas, upon receipt of the deficient documents and further scrutiny, it has been found that

- (i) **Dr. Rayees Hamid Wani** has not responded to the Notice dated 19.12.2025.
- (ii) The publication viz. Clinical and Epidemiological profile of H1N1 influenza A in Kashmiri Children submitted by **Dr. Aijaz Ahmad Bhat** is not indexed in database mentioned in the rule, quoted in the advertisement Notification.
- (iii) **Dr. Zubair Ahmad Najar** has submitted only (01) publication viz; "Life style Patterns and adherence to pharmacotherapy after..." as against requirement of 02 publications, as per rule quoted in the advertisement Notice.

Now, therefore, the candidature of the above mentioned candidates is hereby rejected for the post of Assistant Professor, General Medicine, advertised vide Notificaton No. 03-PSC(DR-P) of 2025 dated 04.02.2025. However, if any of the candidate(s) feels aggrieved with the rejection of his candidature, he may represent before the Appellate Authority of the Commission with documentary evidence in support of his claim, within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period is over.
