1. Brief History & Functions of the Commission

The J&K Public Service Commission was constituted in the year 1957 under Section 128 of the Constitution of Jammu & Kashmir, to discharge the functions specified in Section 133 of the Constitution. However, the Constitution of Jammu and Kashmir has been rendered infructuous on 05 August 2019 by an order signed by the President of India and since then the Constitution of Jammu and Kashmir is not applicable in the Union Territories of Jammu & Kashmir and Ladakh. The Commission is now functioning under Article 320 of the Constitution of India.

Provisions for the J&K Public Service Commission

I As per J&K Re-organization Act 2019. The Public Service Commission for the existing state of Jammu and Kashmir shall, on and from the appointed date, be the Public Service Commission for the Union Territory of Jammu and Kashmir;

II The Union Public Service Commission, with the approval of the President, shall serve the needs of the Union Territory of Ladakh.

III The Persons holding office immediately before the appointed day as the Chairman or other Members of the Public Service Commission for the existing State of Jammu

and Kashmir shall, as from the appointed day, be the Chairman or, as the case may be, the other Member of the Public Service Commission for the Union Territory of Jammu and Kashmir.

IV Every person who becomes the Chairman or other Member of the Public Service Commission for the Union Territory of Jammu and Kashmir on the appointed day under section (3) shall be entitled to receive from the Government of the Union Territory of Jammu and Kashmir, conditions of service not less favorable than those which he was entitled under the provisions applicable to him.

V The Report of Jammu and Kashmir Public Service Commission as to the work done by the Commission in respect of any period prior to the appointed day shall be presented to the Lieutenant Governor of Union Territory of Jammu and Kashmir who shall, on receipt of such report, cause a copy thereof together with memorandum explaining as far as possible, as respects the cases, if any, where the advice of the Commission was not accepted, the reasons for such non-acceptance to be laid before the legislature of the Union Territory of Jammu and Kashmir.

FUNCTIONS OF THE COMMISSION

1. Conducts Competitive examinations and interviews for appointments to various Gazetted Services of the UT of J&K.
- (2) The Commission is to be consulted:-
 - I. On all matters relating to methods of recruitment to Civil Services and Civil posts.
 - II. On the principles to be followed in making appointments and promotions within the civil services.
 - III. Framing and amendment of Recruitment Rules for various Services and posts under the UT of J&K.
 - IV. Disciplinary cases relating to different Civil Services.
 - V. On any matter referred by the Lt. Governor of the UT of J&K.

2. Highlights

1. The Commission during the year under report cleared the promotion/regularization proposals of 2504 officers belonging to different Department. As compared to previous years, there has been exponential increase in the number of regularizations /promotions. In the previous year's i.e. 2017-2018 to 2021-2022 average number of promotions /regularizations remained around 500 per year, while as during the year under report i.e. 2022-23 more than 500% increase has been achieved. This exceptional increase has been achieved by making reforms like during previous years the minutes of the meeting used to be drafted after the DPC meeting which would take weeks together to complete the process, whereas during the year under report, the minutes of the meeting have been framed on the very date of meeting and got signed by all the members of the DPC on spot on the same day resulting in saving of lot of time. Earlier, the minutes used to be circulated among the members through physical mode which also took a considerable time to get approval from the Commission, whereas during the year under report, the minutes were sent through e-office for obtaining approval of the Hon'ble Members and Hon'ble Chairman of the Commission. Likewise in the past, the recommendations would be forwarded to

the concerned Departments through physical mode, whereas, during the year under report, the same have/are being sent through e-office system with the result the recommendations are sent in a matter of seconds.

2. **Regularization/Promotion:** In order to clear the decades old pending regularization/promotion cases, the Hon'ble Chairman demi-officially advised to all the Administrative Secretaries for getting the deficiencies completed in time bound manner and also furnishing proposals against the ensuing vacancies. In achieving this great success, the efforts put forth by the employees of the Commission have been applauded by one and all and even the same has found place in the Hon'ble Lieutenant Governor's address on the occasion of 26th January.
3. The Commission made recommendations to the government for appointments and promotions for 3267 posts which included selection and recommendation of 763 candidates for appointment and promotion of 2504 officers in various Departments (Annexure 01 and 06).
4. **DIGITISATION.** Complete transition from manual to digital mode of functioning as prescribed under digital

India mission. A case in point is the onboarding to e-office mode of working.

5. **NEW RECRUITMENT POLICY:** Jammu and Kashmir public service Commission has made a remarkable shift towards 100% examination based recruitments as per the amendments made in the Jammu and Kashmir PSC (business and procedure) rules 2021. This not only provides a level playing field to all the Candidates but also improves the transparency of the overall recruitment process.
6. **FAST TRACK RECRUITMENTS:** Pace of completion of recruitment process has increased manifold as was seen with Combined Competitive Examination 2021 where the results were declared the same day the interviews were completed.
7. **GOAL OF ZERO PENDENCY.** All the requisitions from the various departments are either completed or under process leading to zero pendency in the Commission.
8. **IDEALS OF TRANSPARENCY & ACCOUNTABILITY:** The highest standards of transparency and accountability are becoming the hallmark in the functioning of J&K PSC signified with fast track disposal of candidate grievances and RTI applications . More than 150 RTI applications and

innumerable grievances were duly disposed off in 2022-23. Further, more than 100 inspections of Examination and Direct Recruitment section records was allowed to the candidates under RTI Act 2005 with complete satisfaction of the applicants which was also appreciated by the Hon'ble Chief Information Commissioner, New Delhi.

9. **Service delivery and Outcome based approach.** Overall reorientation from rules based approach to Service delivery and Outcome based approach.

10. **CREDIBILITY & PUBLIC PERCEPTION:** All the selections recommended by the Commission have stood the test of time and none of the results till now have been called in question on any grounds setting a positive example nationwide. This has helped build credibility and a positive public perception in favor of J&K PSC among the masses.

11. **Performance monitoring systems:** Establishing performance monitoring systems for various sections of J&K PSC with regular reviews at the highest level.

12. **Inclusion of Transgenders:** Implementation of various progressive reforms like inclusion of the option for Transgenders in all the application forms of J&K PSC on the recommendation of

National Human Rights Commission and nomination of a Grievance Redressal Officer for disabled in the Commission

13. **Accolades and appreciation:** J&K PSC awarded for meritorious public service in the UT of J&K on the eve of Republic Day which is a shining reflection of the consistent commitment & contribution of the Commission towards ensuring free and fair recruitments and promotions setting highest standards of Integrity and Professionalism.

14. **Online application forms (OLAF):**

While reviewing the functioning/working of the Commission, the Commission over the years felt that a lot of time is consumed in determination of eligibility of the candidates who apply for a particular post as the process of scrutiny of the documents of the candidates is done manually which at times takes months due to requirement of personal attendance by the candidates in the office at Srinagar/ Jammu for submission of applications etc. It was thus decided to shift to online mode of filing/receiving of application forms. The Commission in a mission mode project in consultation with NIC has been able to shift to online mode within a record time of two months. Presently, application submission process for all the examinations based posts as

well as direct recruitment posts has been computerized and the Commission has started receiving online applications including fees from candidates while in their homes or nearest village/habitations with broad band/internet facilities.

15. One Time Registration (OTR):

A prestigious project of the Commission i.e. one time registration (OTR) has also been taken up for implementation. The project envisages that a candidate shall be provided with a facility of registering himself with the Public Service Commission after having passed graduate level examination. As and when a post commensurate with his qualification will be referred to the Commission, a system generated SMS and an e-mail shall be sent automatically to the candidate registered with the Commission intimating him/her that he/she may like to apply for the referred to post. The candidate once registered with the Commission as the name suggests would not be required to register again and again. He would simply be required to upload the information with regard to his qualification/higher qualification as and when he/she upgrades his/her qualification. Depending upon acquiring of higher qualification his/her eligibility for other posts shall also be generated. This system shall provide

up-to-date data about unemployed youth in the State and other eligibility/availability for various categories of posts.

16. Computer Based Recruitment Test (CBRT):

The Commission has started the Computer Based Recruitment Tests in the UTs of J&K and Lakshkar which has no parallel so far as transparency and utilization of minimum time for generation of results is concerned. Initially it has been conducted for recruitment of posts involving less number of candidates. Gradually, it will be extended to all posts depending upon the availability of logistic infrastructure with the service providers.

17. Uploading the information on official website of the J&K-PSC:

The Commission has also started uploading the information on the official website as an alternative to providing of information through RTI, Act wherever possible.

18. Opening of Examination Centers in far flung areas:

The Commission with a view to reaching out to the weaker sections and backward areas decided to conduct preliminary examinations for Combined Services (JKAS/JKPS) and other competitive examinations in the far flung areas to

enable the poor students who because of their financial constraints do not appear in the competitive examinations and other written tests as the same were held in the centers located in the Jammu and Srinagar cities only. The written tests for other posts are also being conducted in these districts depending upon the strength of the candidates.

19. Legal section of the Commission, has got the 35 no. of cases dismissed / disposed of during the period under report. The notable cases which has been disposed of are given as under:

- a. The case titled Khan Atif Abdullah vs UT and others dismissed and penalty of 5000 was imposed on the petitioners. The petition had challenged the KAS 2021 notification.
- b. The section is working like the first line of defense for the Commission so that no selection is halted and the candidates are recommended on time for appointment thus enabling the Commission to play its role in a time bond manner.
- c. The stay got vacated in case titled Muzamil Majid vs UT within one month from its order, enabling the Commission to recommend cream of newly selected candidates for the post of AE Mechanical.

20. **On Screen Evaluation:**

The Commission has switched over to the "On Screen Evaluation" system to ensure error free evaluation and to avoid delay in selection process.

21. **Selections Schemes for 2nd Gazetted level posts & specialized ones in Health & Medical Education and Higher Education Departments:**

The Commission keeping in view the guidelines of Medical Council of India & UGC has decided to conduct written tests for all the posts referred to JKPSC especially 2nd Gazetted level posts & specialized ones in Health & Medical Education and Higher Education Departments

22. One departmental Examination was conducted during the year under report viz SAC (old course/Foundation course/J&K SATC wherein 2082 candidates appeared. (*Annexure 15*).

23. The commission conducted 13 Screening tests/ Written Tests and 02 Main examination and one preliminary Examination. (*Appendix – 22*).

24. The Commission, didn't held any Examinations on behalf of the Union Public Service Commission. (*Appendix – 16*).

25. The Commission, declared the results of 14 Screening Tests/written Tests and 03

main Exams during the year. (*Appendix – 14*).

26. Total numbers of 1686 posts of various categories were advertised in different Departments for Direct Recruitment through Interviews/Examination. (*Appendix-18*).
27. The Commission conveyed its agreement to the Draft Recruitment Rules to 01 Department viz Housing and Urban Development Department (*Appendix-11*)
28. The Commission received requisitions for 982 posts from 21 Departments for selections (*Appendix-13*).
29. The calendar as per the provision of the SRO-166 of 2005 is not strictly followed by the Departments. The Departments are required to refer vacancies falling under

direct recruitment quota by 15th of January every year and also refer vacancies under promotion quota twice a year, as per the calendar devised by the Commission

30. This has been observed that departments in most of the cases do not furnish complete information and supporting documents with their proposals which leads to unnecessary and unavoidable delay in clearing the cases for departmental promotions.
31. The cases pending in various courts of Law are not properly defended by the respondent departments causing delay in the selection process.

3. Work load over the years

1. The functions of the Commission specified in section 133 of the Constitution are:

- (a) Recruitment to various Gazetted services of the State by:
 - (i) Written Examination with viva voce/ interview;
 - (ii) Interview;
- (b) Appointment by Promotion;
- (c) The Commission shall be consulted:
 - (i) On all matters relating to methods of recruitment to Civil Services and for Civil posts.
 - (ii) On the principles to be followed in making appointments to civil services and posts and in making promotions and transfers from one service to another and on the suitability of candidates for such appointments, promotions or transfers;
 - (iii) On all disciplinary matters affecting a person serving under the Government including memorials or petitions relating to such matters; and
 - (iv) It shall be the duty of the Commission to advise on any matter so referred to

them or any other matter which the Governor may refer to them.

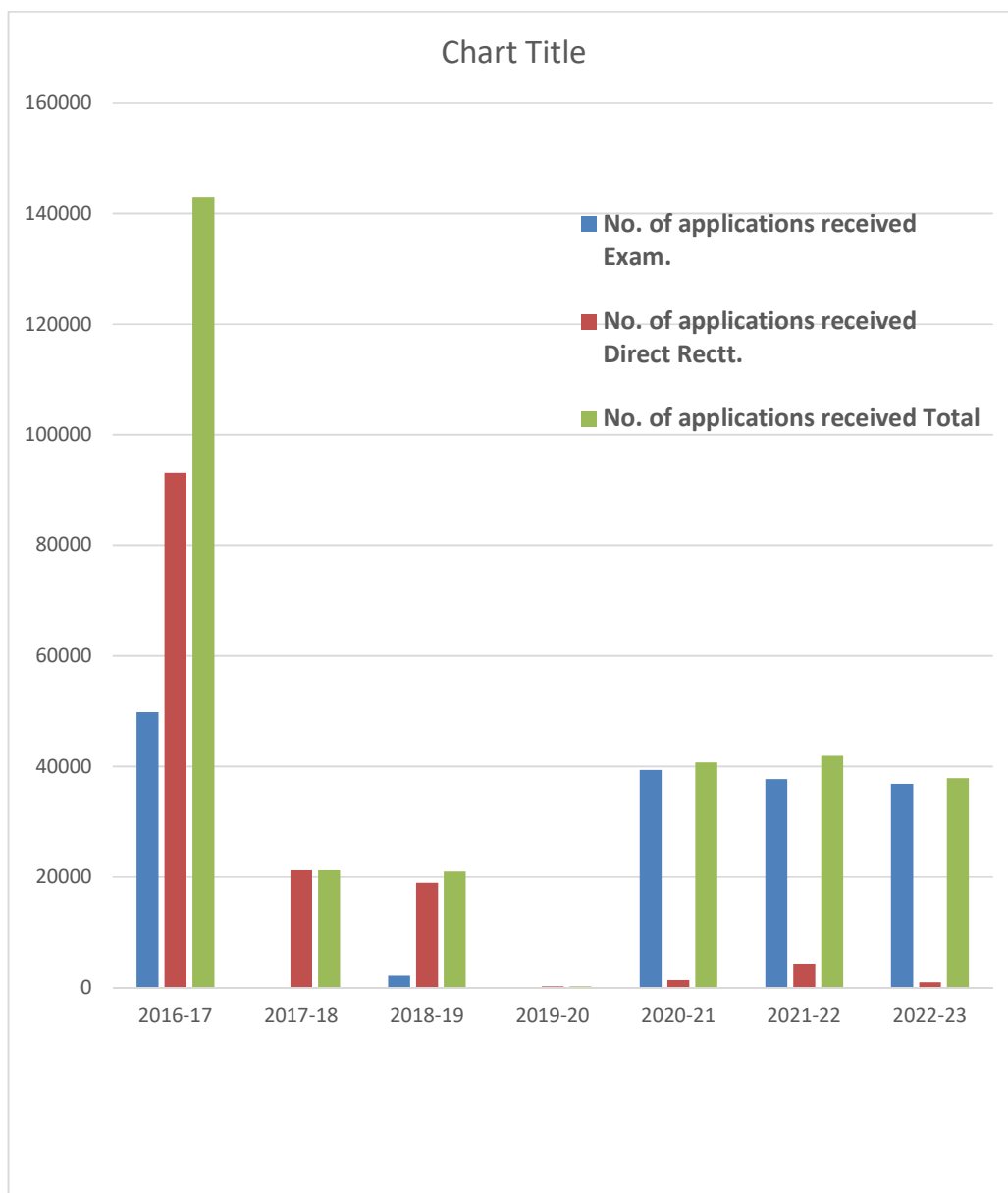


Diagram depicting No. of Candidates interviewed for various posts under Examination, Direct Recruitment and Total over the years.

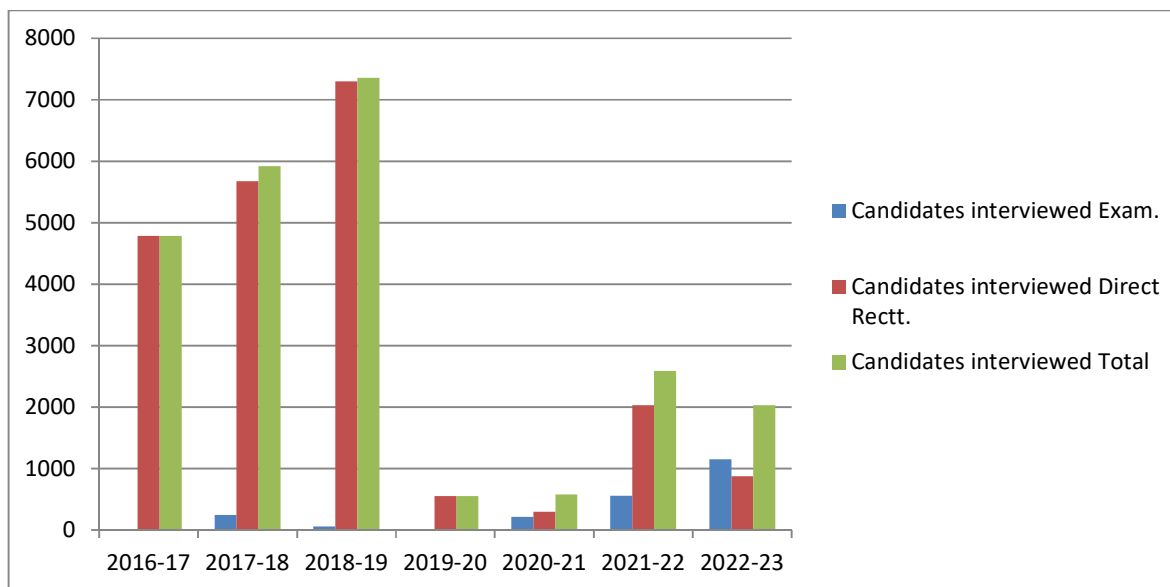


Diagram depicting No. of Candidates recommended for various posts under Examination, Direct Recruitment and Total over the years.

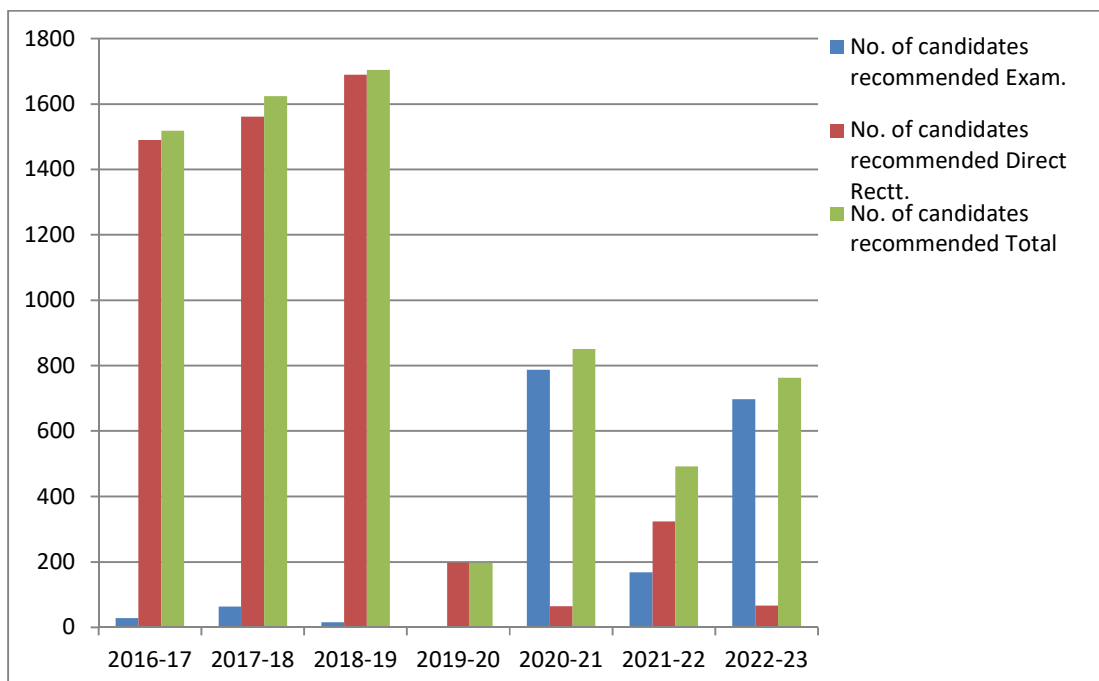

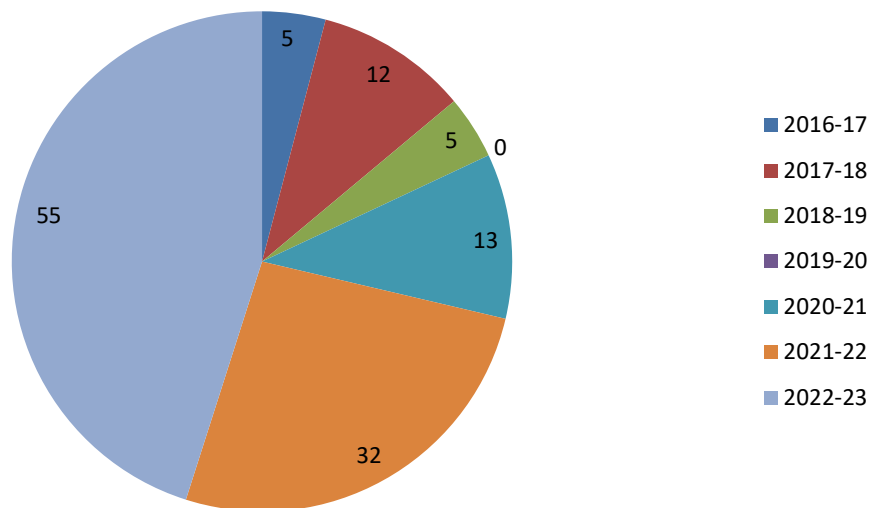

No. of candidates appeared

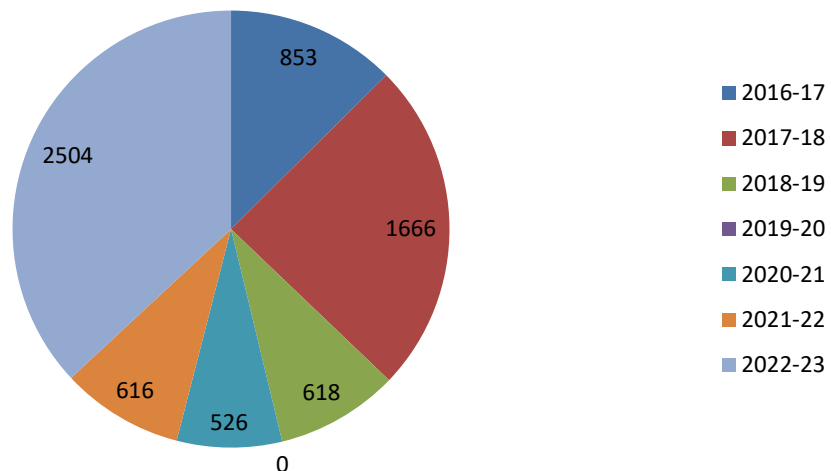


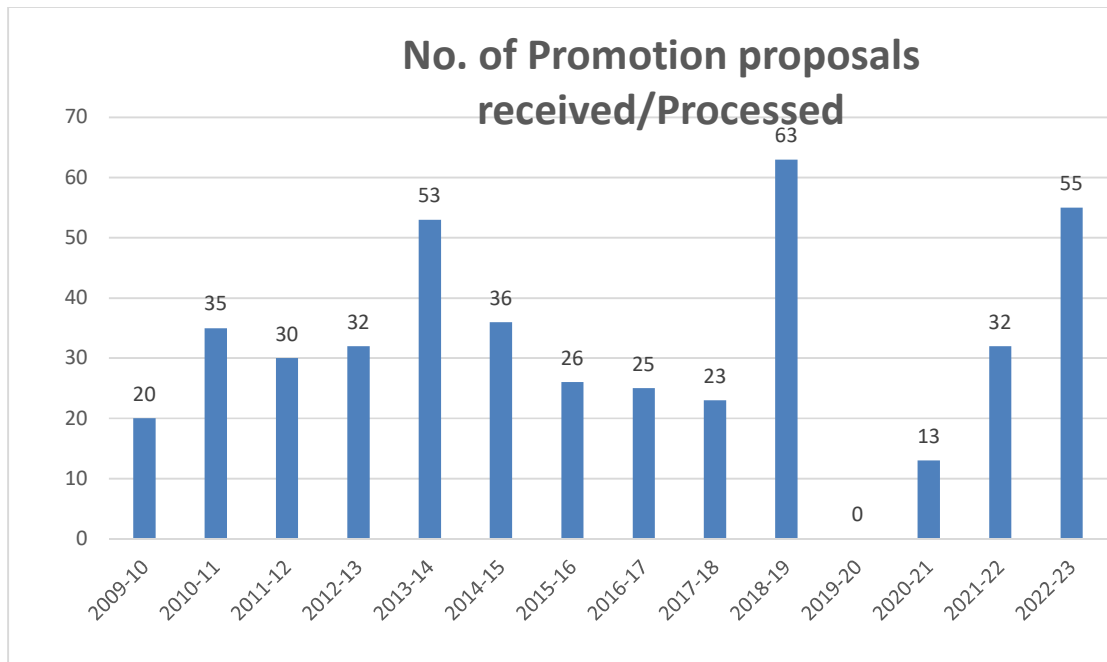

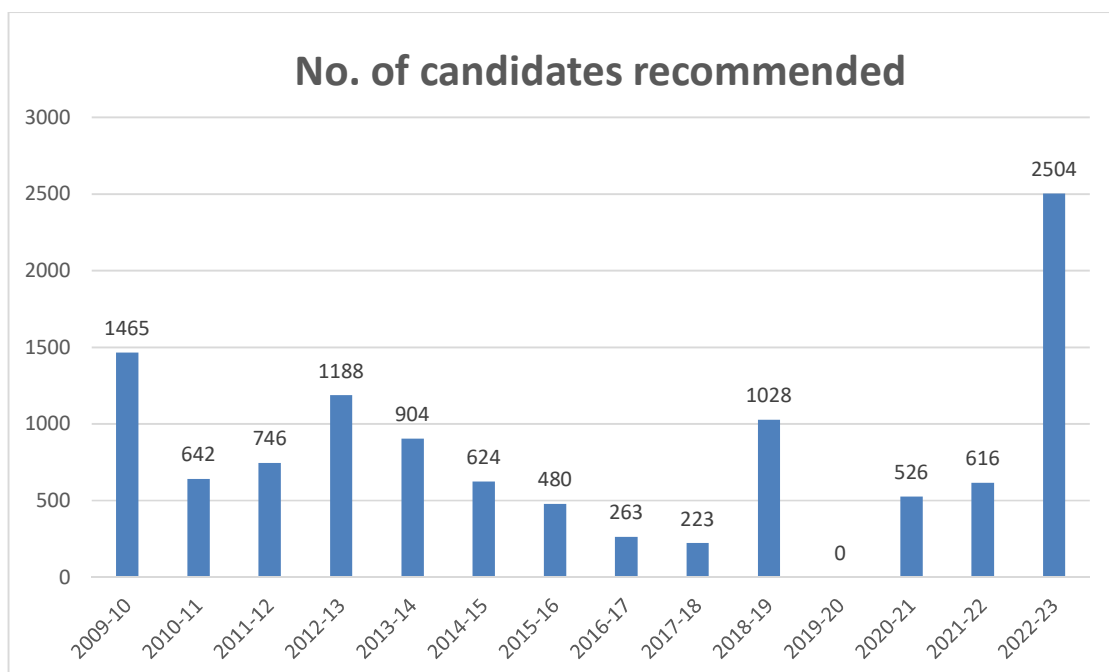
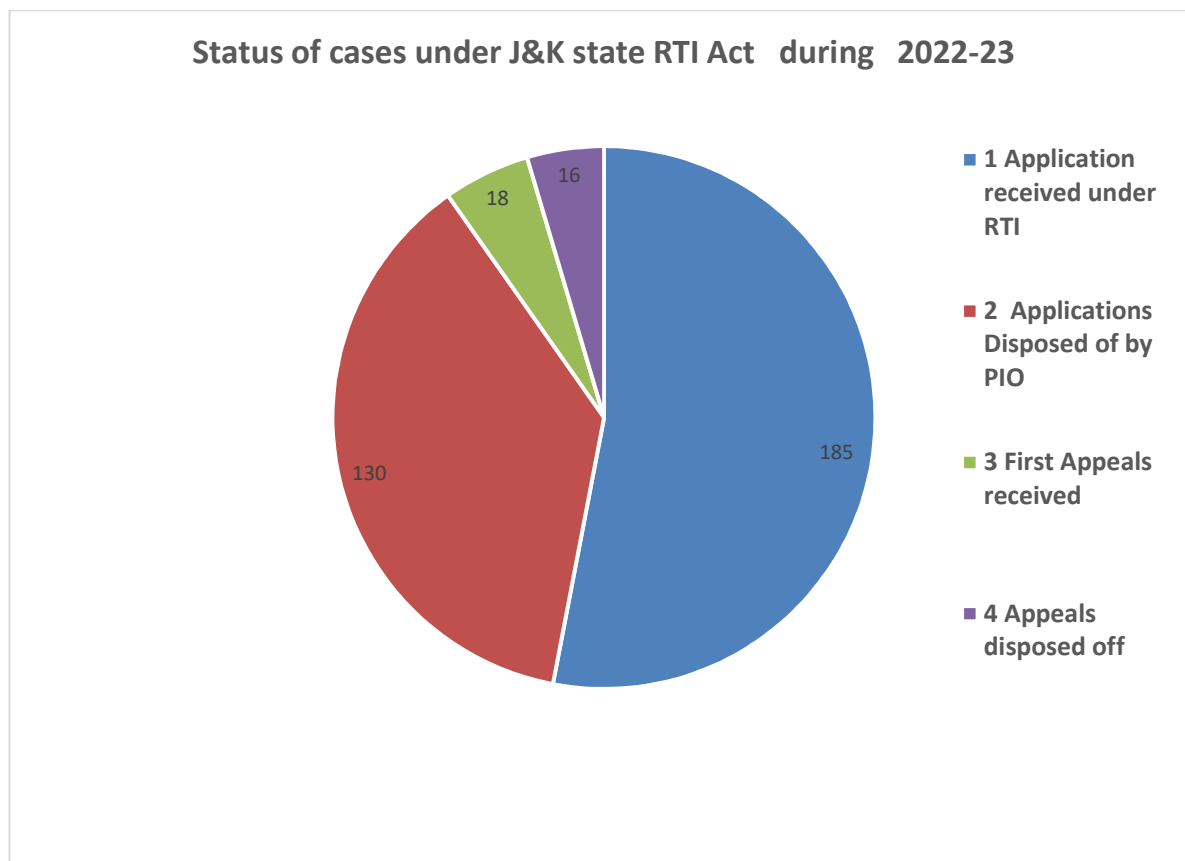

4.Direct Recruitment by selection

Direct recruitment by selection was made for filling up of vacancies referred prior to issuance of the SRO:-438, dated:-11-12-2015, as per the relevant recruitment rules in vogue i.e. by direct interview after short listing the candidates by conducting screening tests wherever necessary.

The process of recruitment by interview started with the receipt of a formal requisition from the indenting department. This was followed by the advertisement of the posts, receipt of applications, determination of eligibility and short listing by holding screening tests where the

number of applicants exceeded 350 for the posts upto 100 and finally the holding of interviews. The selection process culminated with the making of recommendations by Commission to the Government for appointment of suitable candidates. Direct recruitment by selection for the posts referred after 11-12-2015 was made strictly as per the above mentioned SRO. During the

year under report, the Commission made 66 recommendations for direct recruitment by interview. The category-wise break-up of 1689 candidates recommended for appointment in various categories is as under:

1. OM=45, 2. SC= 4, 3. ST=3, 4. RBA= 14

During the year **2022-23**, the Commission received 12 requisitions involving 982 posts from various Departments of the State. The

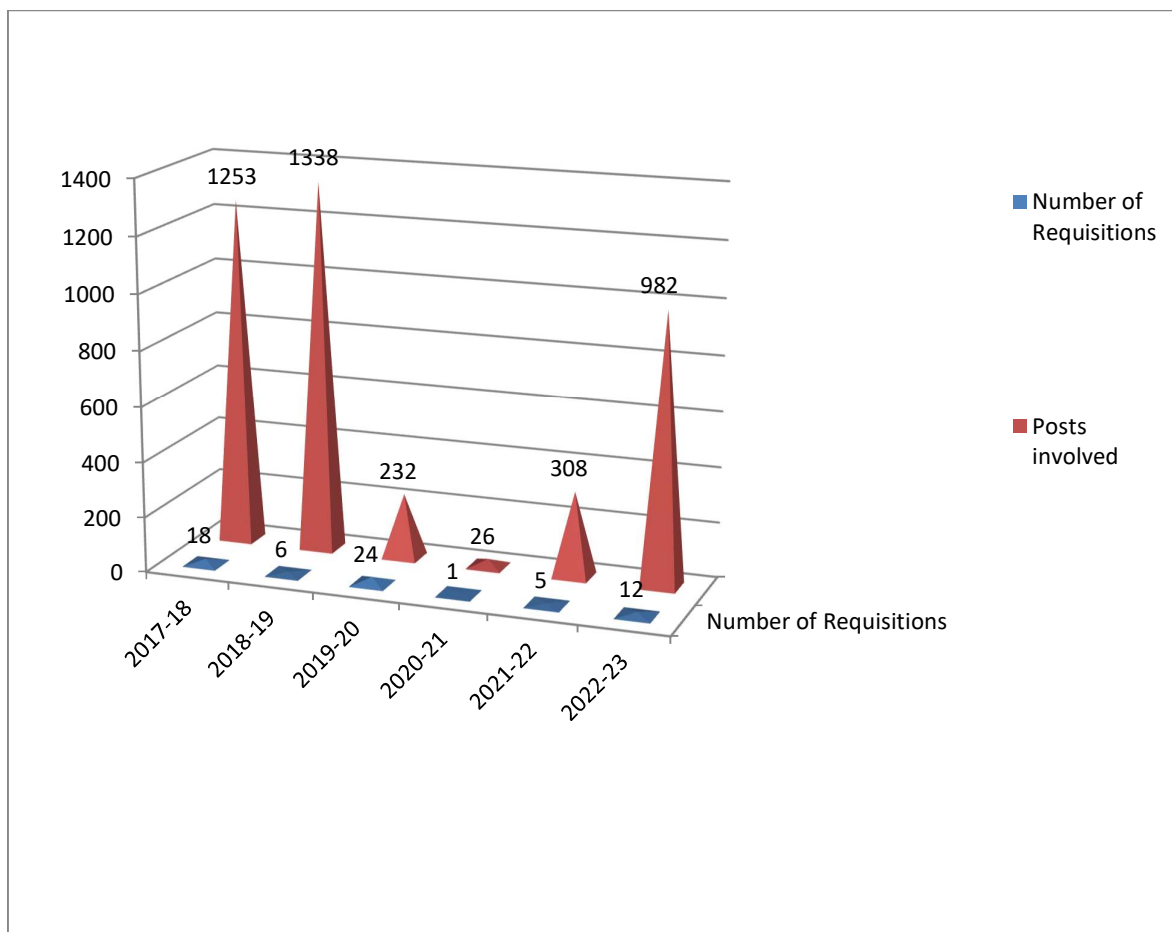

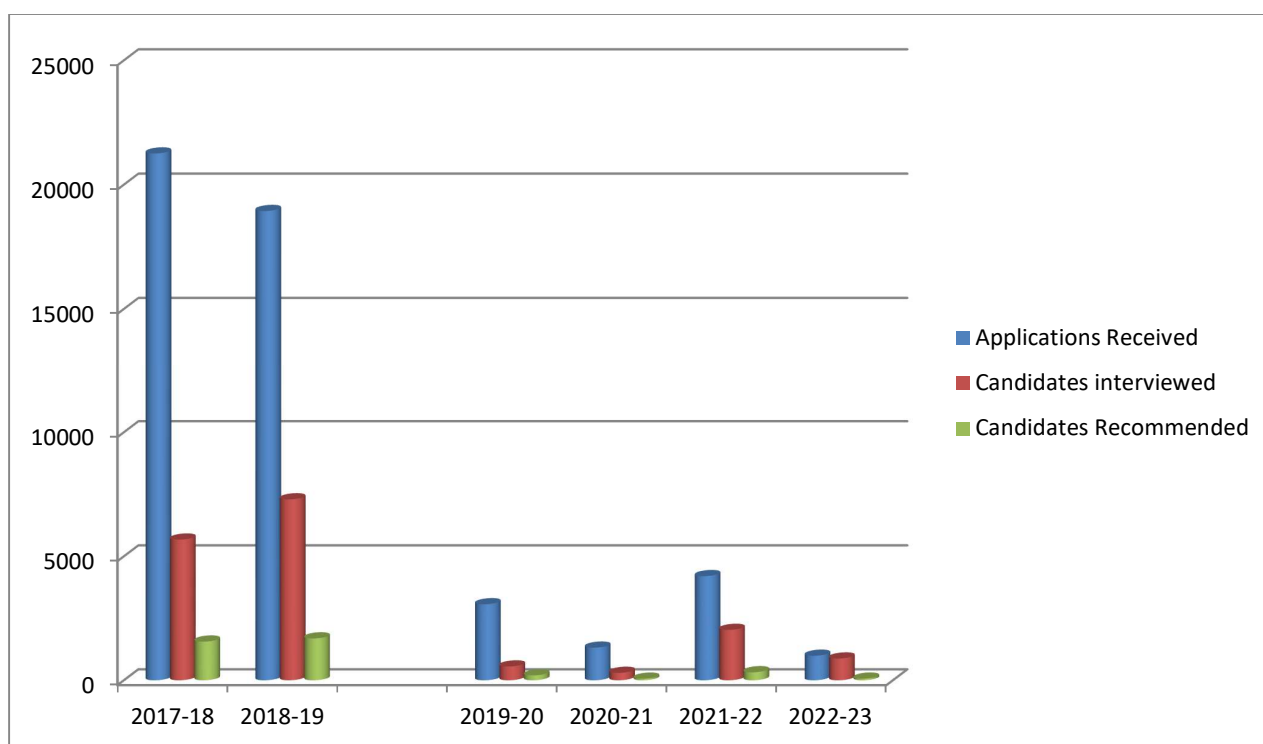

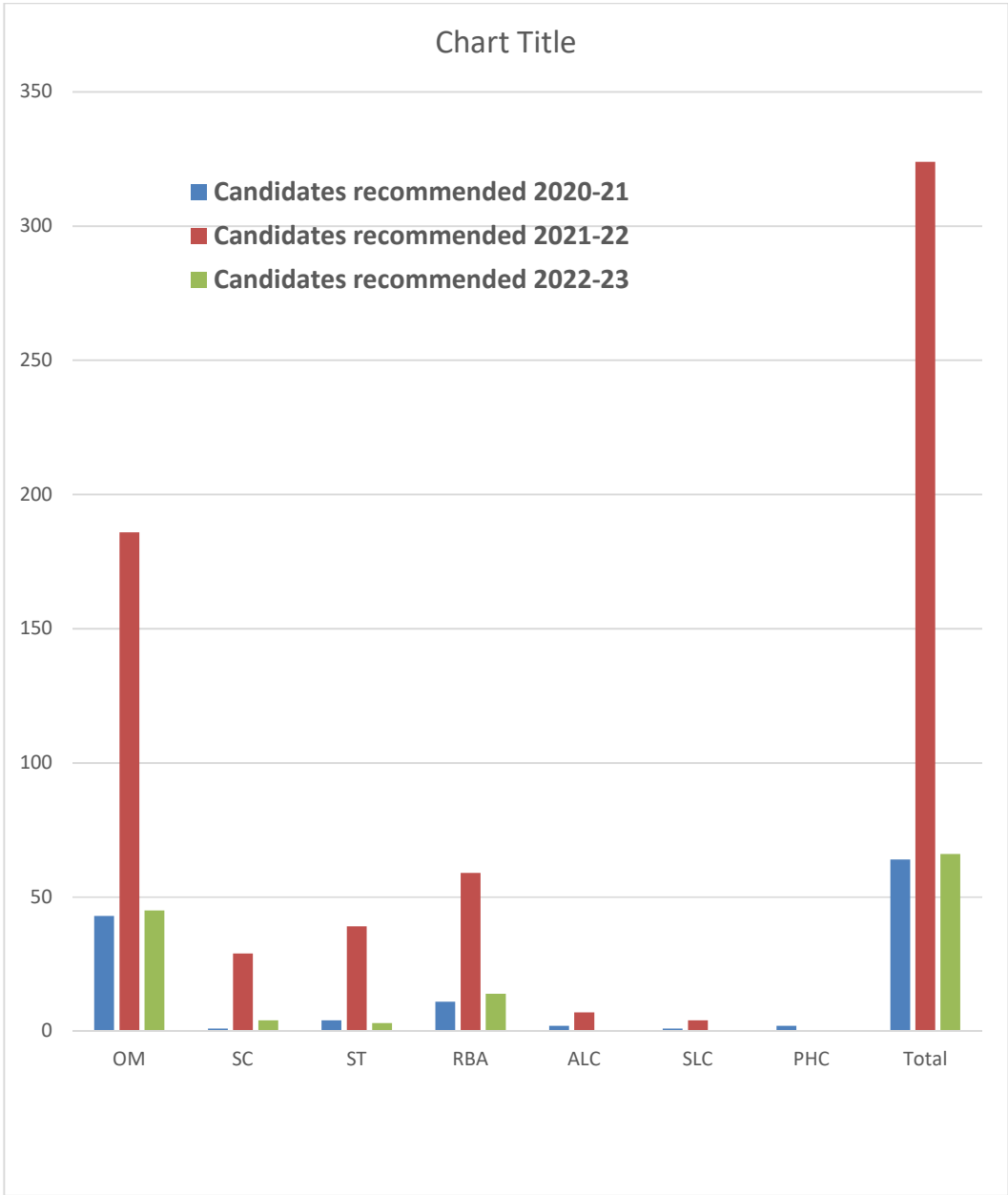

5. Recruitment by Examination

The Competitive Examinations, wherever provided in the recruitment rules, are held for filling up of the posts referred to Public Service Commission by various indenting Govt. Departments. In this method, recruitments are made by holding Competitive examinations followed by viva voce/interview. The pattern, the syllabi etc. of the

competitive examination is provided in the relevant recruitment rules. During the year 2022-23, 763 posts have been recommended to various Departments for selection against 1071 posts under 4 Competitive Examinations. The post wise detail of selections is given in Appendix-I

(i) No. of requisitions received and posts involved during 2022-23 (Appendix-13)

During the year 2022-23, only 12 requisitions involving 982 posts were received from 21 Departments. The number of requisitions received

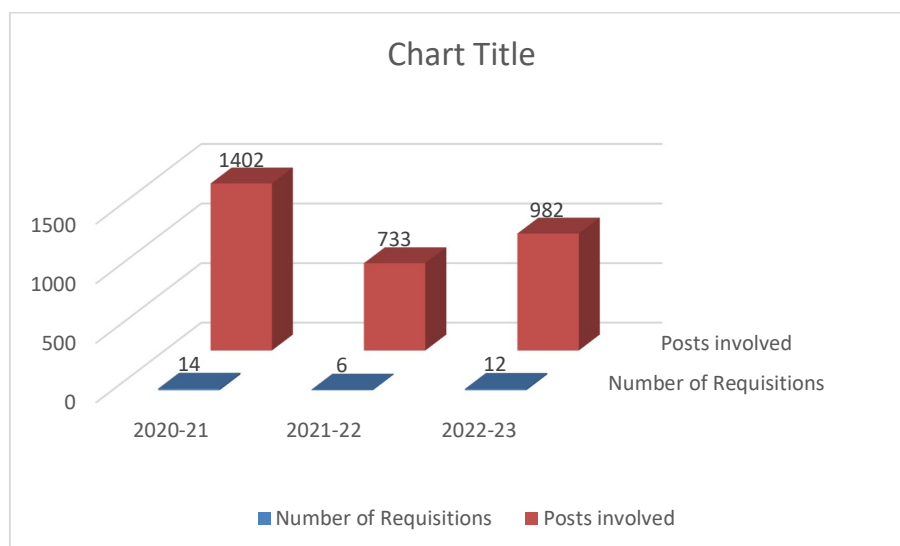

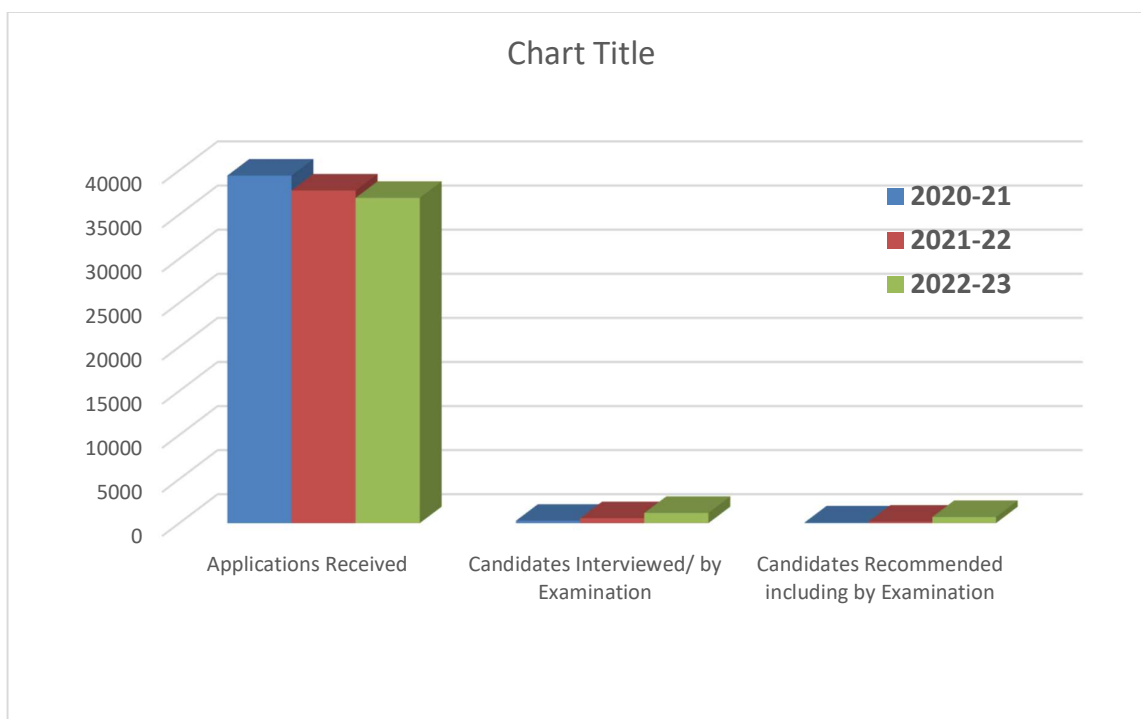

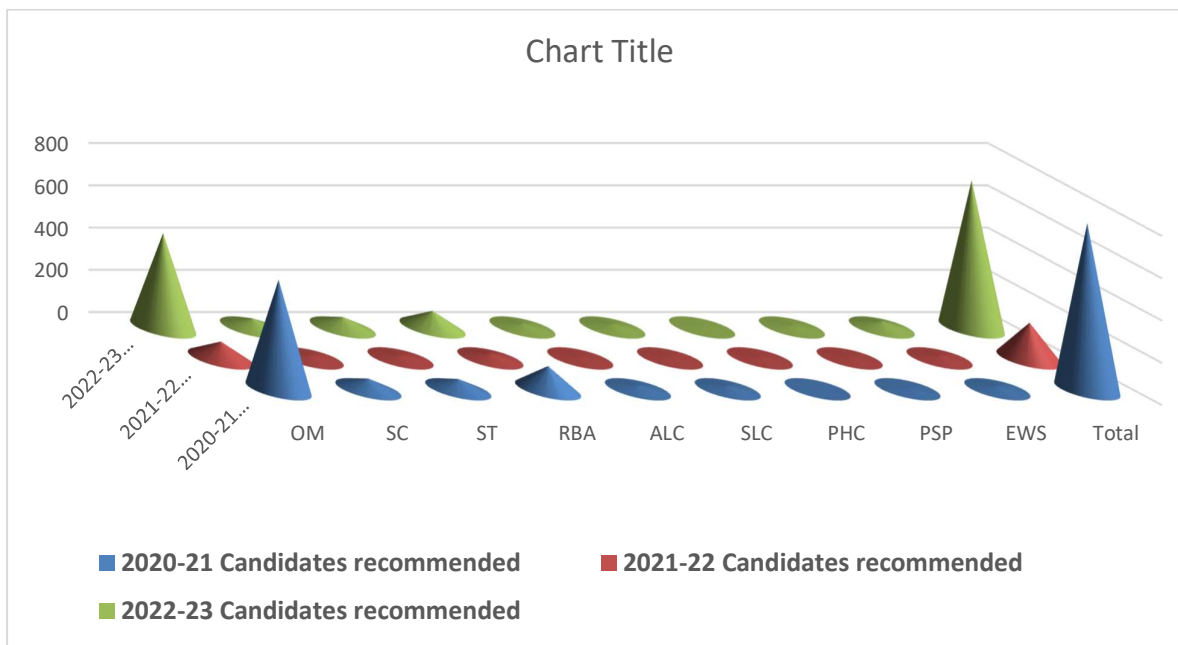

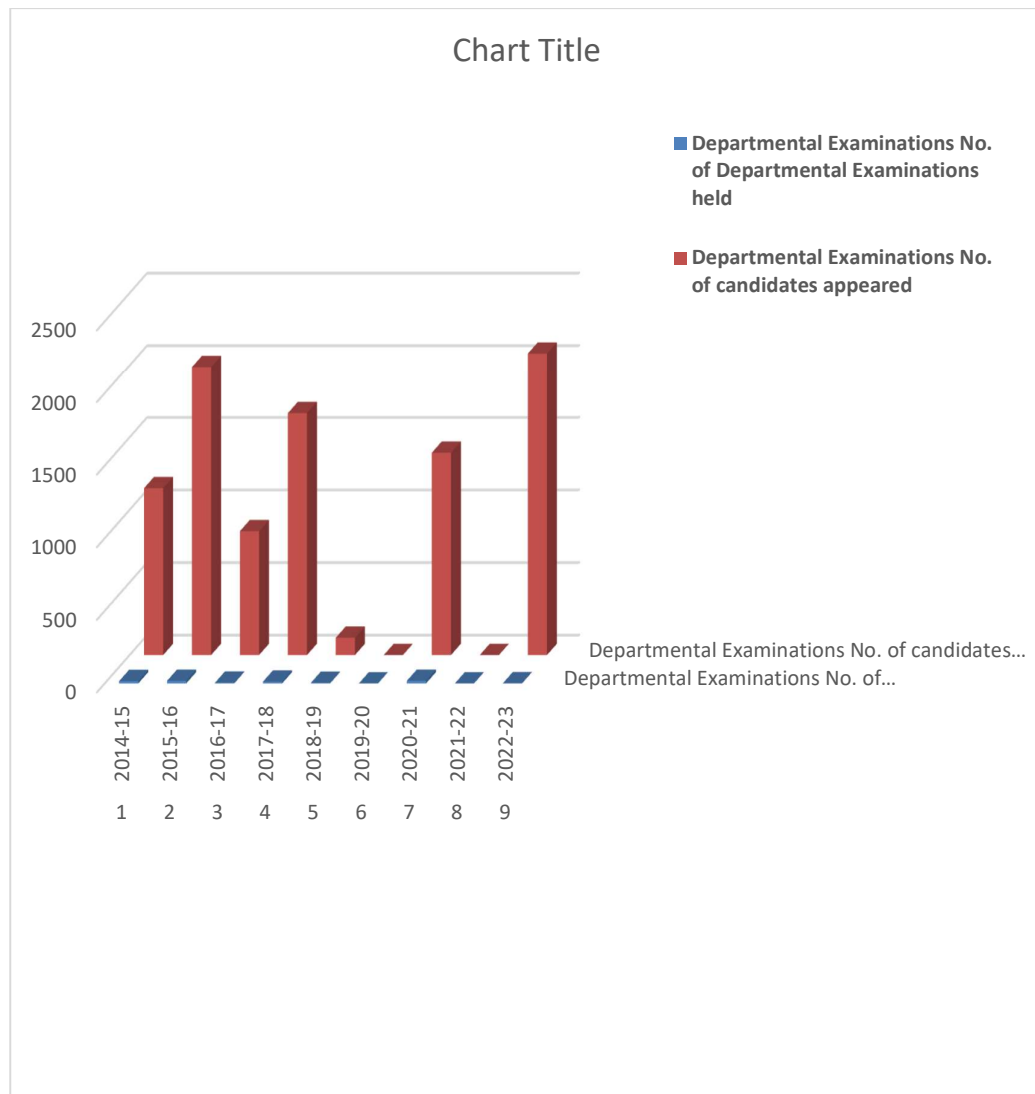

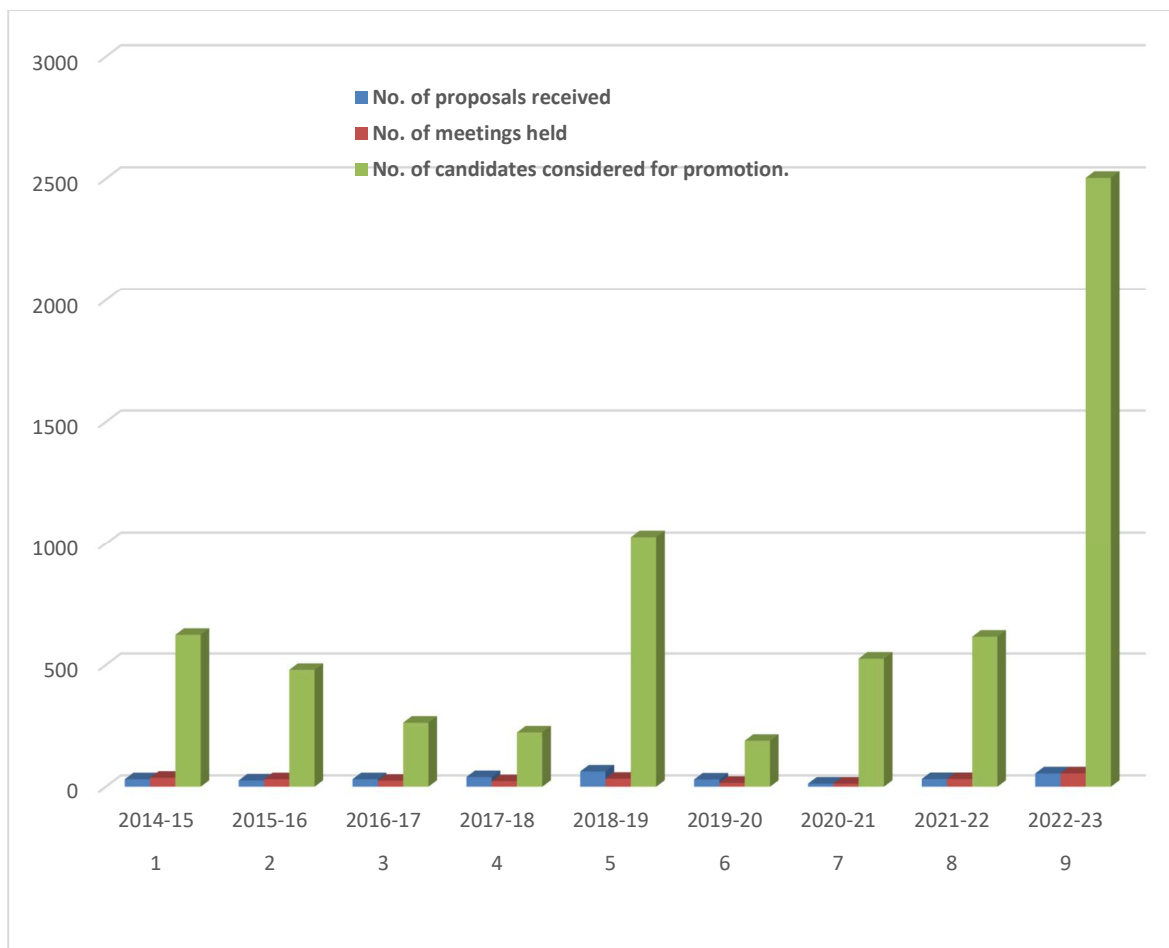

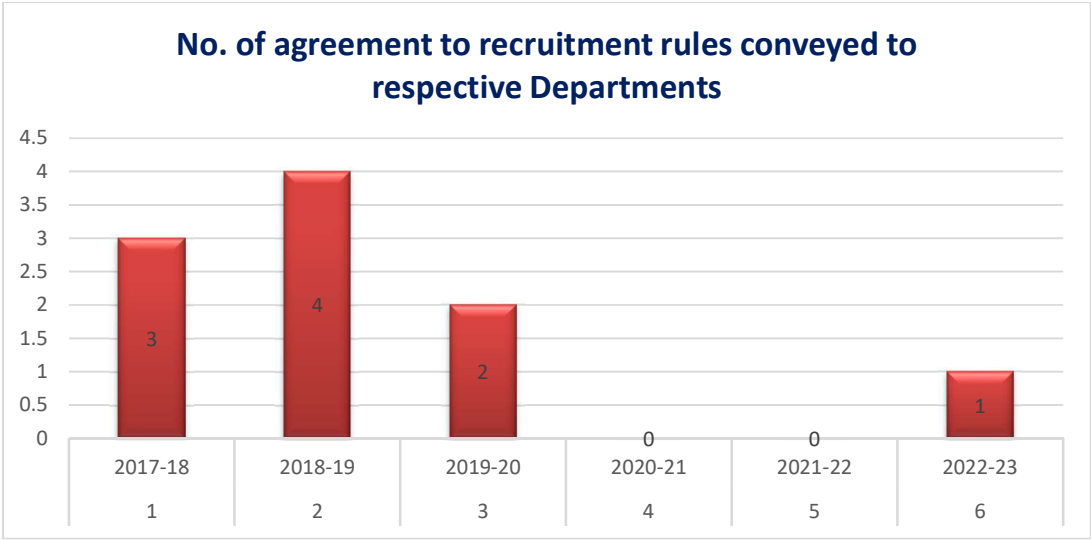

8. RECRUITMENT RULES / ADVICE RENDERED

The Recruitment Rules in respect of 04 services, pertaining to 03 departments viz, 1) Animal & Sheep Husbandry Department 2) Health & Medical Education Department 3) Department of Skill Development could not be finalized on account of various reasons including deficiencies, as indicated against each, in appendix –9.

The Commission conveyed its agreement with regard to Recruitment Rules to different department every year, but the Commission is not aware whether the SROs have been issued or not as the Administrative Departments are not forwarding copies of the same to the Commission.

The Commission wishes to express its dismay that the list of such cases is increasing year by year and that little or no effort is being made by the concerned departments to notify the rules.

The Commission finds it difficult to monitor the action taken by the departments on agreements conveyed by the Commission to the Recruitment Rules unless a copy of the SRO issued by the department is sent to it. There may be cases, which figure in the Commission's list of pending cases where the department may have actually issued the Recruitment Rules, but no copy of the SRO notification has been received by the Commission.

The Commission has noticed that amendments are made in certain service rules without prior consultation of the Public Service Commission. It needs to be emphasized on the Administrative Departments to comply the constitutional requirement in this regard as required under section 124 of the Constitution of Jammu and Kashmir.

9. MISCELLANEOUS

WRIT PETITIONS

During the year under report, comparatively, fewer writ petitions, in which the Commission is the primary respondent, were filed before the Hon'ble High Court of J&K. In most of the writ petitions pertaining to the Commission, criteria of selection/recruitment rules have been challenged. The Commission is regularly filing counters/objections in the courts and monitoring the progress of cases with its Standing Counsels. Due

to regular follow up of the Court cases, the Commission has been able to get maximum number of court cases, particularly the Court cases of Higher Education Department, Health and Medical Education Department and General Administration Department (KAS) decided in favour of the Commission. The department wise detail of court cases is enclosed as appendix-23

The names of Ex-Chairmen and Members of the J&K Public Service Commission to the extent of records available are given in the Appendix- 24.

13. Reference of vacancies and holding of meetings of Departmental Promotion Committees.

The Commission notices with concern that the departments are not following the instructions issued by the General Administration Department from time to time in terms whereof all the departments were required to:

- (i) Refer vacancies falling under direct recruitment quota to J&K Public Service Commission and Service Selection Board by 15th of January every year (except in the case of Combined Competitive Services which shall continue to be governed as per the existing procedure); and
- (ii) Refer the vacancies under the promotion quota to J&K Public Service

Commission/Departmental Promotion Committee, twice a year, preferably in the month of January and July for convening DPC meetings.

- (iii) As such, it is suggested that Government may issue instructions to all the departments that the provisions of the SRO-166 of 2005 be implemented in letter and spirit, so that the system of promotions is streamlined and a lot of litigation be obviated as also the process of selection against the direct recruitment quota is initiated/completed in a regular manner.

10. DIFFICULTIES AND DELAYS

(a) RECRUITMENTS: -

As already mentioned in the Annual Report of the previous years, the response of the indenting departments to the issues raised by the Commission from time to time, has not always been as timely as desired. As a result, the selection/regularization process is delayed, sometimes for want of even a minor clarification.

It is desirable that the departments must send their formal requisitions for direct recruitment in Form-1 complete in all respects.

Many times departments have been found to leave various columns of Form-1 incomplete. As such some important information that should have been forthcoming, from the Form-1, remains missing which results in unnecessary delays. The Commission wishes to impress upon those heading the indenting departments of the State that they should personally ensure that, while posts are being referred to the Commission, all the necessary information is furnished.

(b) PROMOTIONS: -

Majority of promotion cases remain pending for want of issuance of a final seniority list, annual performance reports, integrity certificates, recruitment rules and the year-wise breakup of vacancies with reference to the cause of vacancies. The Commission would like to impress upon various departments of the Government to

furnish expeditiously, any information/document, asked for by the Commission. The departments, while sending the promotion proposals, should send their cases with complete documents, as required under rules. The details of pending promotion cases with reasons of pendency are given in appendix-7.

11. RECOMMENDATIONS

The Commission has been making recommendations in its Annual Reports highlighting the documents required for speedy disposal of cases of promotion and recruitment by examinations/interviews, but these have not been heeded to by a number of departments. The Commission hopes that in future these recommendations would be seriously considered by the Departments. The recommendations are as under:-

1. The proposals for regularization are not being submitted by some of the Administrative Departments in the forms as prescribed in the Government Order No. 1303-GAD of 1969 dated 28.06.1969, besides the PSC has issued circular, vide No. 1 PSC of 2016, dated 15-01-2016, where under, procedure/schedule for conducting DPC on monthly basis has been circulated among all the departments to make the process easy. But the instructions/schedule have not been followed in letter and spirit.

Keeping in view the uniformity and objectivity of DPC, the Commission has issued a revised checklist (Appendix-25) vide Order No. 01 PSC of 2019 Dated 08-07-2019. The same has been forwarded to all the Administrative Departments under endorsement No. PSC/DPC/01/2016 dated 08-07-2019. Besides, a copy of the same has also been forwarded to the General Administration Department vide No. PSC/DPC/Checklist/02/2019, dated:- 23.01.2019, for circulation among all the

Administrative Departments with the directions to adhere to the checklist in letter & spirit while preparation/submission of DPC proposals.

The Details of DPC Proposals received/not received from the Departments during the year under report are mentioned in appendix-8.

2. It has been observed by the Commission that some departments submit the proposals for DPC only upto first Level Gazetted Officer i.e.; Under Secretary, Private Secretary etc. to the Commission. The DPCs of higher posts are being done by the Administrative Departments at their own level. It is recommended that DPC Proposals up to the Level of Additional Secretary may also be submitted to the Commission on the analogy of Finance, PWD (R&B), and Planning Development & Monitoring Departments etc.
3. The APRs received from various Departments are often found incomplete. Although there is a provision in APR rules that in case of non-availability of requisite APRs due to certain reasons, the Administrative Secretary may furnish the work and conduct certificates in lieu of APRs with the reasons for non-availability of requisite APRs. But some of the Administrative Departments established a practice to furnish work and conduct certificates without reasons as an alternative of APR's. This practice needs to be stopped. The Administrative Department while furnishing the proposals should ensure that APRs are properly reviewed and accepted by the

competent authority and are complete in all respect.

4. The work and conduct/Integrity certificates received from the various departments are not signed/counter-signed by the concerned Administrative Secretaries. Administrative Departments should make it sure that work and conduct/integrity certificates are duly authenticated by the concerned authorities.
5. It has been observed that after submitting the proposals, the Administrative Departments do not bother to respond to the communications regarding the deficiencies or any query regarding the proposal which results in inordinate delay.
6. The Administrative Departments shall ensure the timely/relevant reply of queries/ Communications for speedy disposal of DPC cases. The departments whose cases are pending for want of clarifications are mentioned in appendix-7
7. Some Departments, while submitting the DPC proposals to the Public Service Commission, do not adhere to the incumbency position.
8. Some of the departments do not represent in the DPC meetings on the date fixed by the Commission. In exceptional cases, where the Departments are not in a position to attend the DPC meetings on the scheduled date due to some unavoidable circumstances, the same shall be communicated to the Commission well before two days of the scheduled date of DPC meeting.
9. The proposal for seeking concurrence of the J&K PSC on the draft recruitment rules are being submitted incomplete by some Administrative Departments in respect of comparative statements, creation/abolition orders and

concurrence of the Finance Department in case of change of nomenclature/creations of posts. In order to make uniformity the Commission issued checklist for submitting draft recruitment rules and the same has been forwarded to all the departments. The Administrative Department shall ensure that all the pre-requisite documents as mentioned in the checklist (Appendix-26) are enclosed while submitting the proposal to the J&K PSC. Moreover, Recruitment Rules of most of the Departments have neither been updated for many years nor has sanctioned strength of the cadre/posts been defined. Updation of rules is strongly recommended.

10. The DPC clears the officers for regularization on the principle of availability of vacancies, placement and eligibility whichever, is later in accordance with the provisions of Govt. Order No.743-GAD of 2007, dated 28.06.2007. It has been found that due to delayed placement of eligible officers against higher posts, they are put to a disadvantage. A mechanism needs to be evolved to fill up the vacant posts on stop gap basis in accordance with rules immediately after these become available for a period of six months to avoid hardships to the officers. Moreover, Government order dated 28-06-2007 needs to be reviewed, as it adversely affects officers who for no plausible reason or justification are left out and later on they are deprived of the benefit of promotion, if retired. In scores of cases, the Commission has noticed that without any justification, the departments ignored otherwise eligible officers and juniors are placed on higher posts. The condition of placement for

regularization needs to be revived to ensure fair play and justice to all.

11. The Government Instructions under Article 85 of J&K CSR provide that it is wrong in principle to appoint a Government Servant to higher post in his own cadre/line of promotion without observing the required formalities of clearance from Departmental Promotion Committee. However, for reasons to be recorded, the Administrative authorities cannot, without detriment to public interests, wait for formal appointments, temporary stop-gap arrangements may be made by them against such posts. In making such arrangements the competent authorities should ensure that only such officers are appointed who fulfill all requirements for higher appointments and can stand the scrutiny of Departmental Promotion Committees. Persons so appointed shall be appointed in their own pay and grade as in charge of higher posts, and will be required to discharge the duties and responsibilities of these posts. As soon as these officers are declared by the Departmental Promotion Committee fit for appointment to higher posts without any break in stop-gap arrangements, they will be allowed full pay and allowances of those posts, if any, drawn to be adjusted in full against the retrospective increase in pay. As per Article 85 of the J&K CSR, Own Pay & Grade (OPG) arrangement shall not last beyond 6 months. However, Officers placed in OPG, continue beyond 6 months which is gross violation of the Art. 85 of J&K CSRs and against the spirit of judgment of the Apex Court passed in

the case titled Suraj Prakash & Others V/S State of J&K & Others.

12. Grades have been released by some Administrative Departments at the time of placement, which is gross violation of the rules. The Administrative departments should release the grades only when the DPC/PSC recommends regularization of the services of such officers.
13. The final seniority lists need to be updated and issued regularly. Some of the Departments, while updating the seniority lists unnecessarily show the whole seniority list as tentative which makes otherwise final position of the officers tentative.
14. Some Departments have adopted the practice of submitting the documents at the time of DPC meeting. Such documents submitted at the eleventh hour are not being properly scrutinized /examined. This practice required to be stopped and encourage the procedure of submission of complete documents with the proposal enabling the Commission to properly scrutinized/examined the proposal in all respect well before the DPC meeting.
15. The Administrative Departments should adhere to the schedule for referring vacancies, at the end of the year in respect of direct recruitment quota and at the beginning and middle of the year, for promotion quota to the PSC taking due care of quota as per recruitment rules of the service at regular intervals and avoid making piecemeal reference of vacancies and the related information. The Commission also recommends that all the Government Departments be directed to comply strictly with the directions contained in the SRO-166 dated 14.06.2005, including the

timely completion of APR's, issuance and updating of seniority lists, updating of schedules to the recruitment rules as well as the nomination of Nodal officers from each department, who will be duly trained to ensure compliance with these requirements and to bring to the notice of the concerned Administrative Secretary, instance of slackness, if any, in adhering to the provisions of the SRO-166 of 2005.

16. Except a case received from Horticulture Department, the Commission is not receiving cases on disciplinary proceedings. During the last four years, not a single such case has been received by the Commission. This is in violation of Section 133I of the Constitution of the State where-under Commission shall be consulted on all such matters.
17. The Syllabi of the Departmental Examinations of all Departments, need to be updated and brought in tune with the changing requirements, particularly Computer subject be introduced as one of the paper in every Departmental Examination. The departments be advised to prepare the revised syllabi in consultation with the Commission and also consider, if some papers can be prescribed on objective type basis.
18. The Departments after referring the vacancies do not respond to furnish the deficiencies, if pointed out. Priority heed of the Administrative Departments in the matter is recommended to avoid delay in the selection process.
19. Some departments provide for allowing the candidates to use Bare Acts in the examination. This needs to be reviewed and the use of Bare Acts needs to be dispensed with.
20. Recruitment Rules of most of the State Government Departments framed decades ago are very old, outdated, obsolete and have become redundant and require their revisions and updating to keep pace with the fast changing social, economic and technological scenario, as well as efficiency and expertise required for handling assignments of complex nature in view of the diversification and specialization in the field of governance and functioning of government organizations. It is also necessary to accommodate and incentivize diversification in the field of Education, Medical Sciences and Computer Sciences. The updating and revision of Recruitment Rules to the matching requirement of the functioning of the Government Departments will also bring down the incidences of litigation. It is recommended that the Recruitment Rules of the Government Departments shall be revised /updated urgently.
21. Some posts have been created in various departments which have not been added in the hierarchy, resulting in dissatisfaction among the employees. This aspect needs to be looked into.
22. While reviewing the Recruitment Rules, there is a need to build proper pyramids to provide reasonable vertical movement in the ladders. It cannot be uniform amongst the services, but such vertical movement can be made compatible amongst the various services.
23. While amending the Recruitment Rules, the departments also need to consider the minimum qualification for the posts. It has been noticed that in various departments, certain category of posts are eligible for promotion to the next level

post even without basic minimum qualification as per the existing Recruitment Rules of the concerned department.

24. Mechanism of Vigilance Clearance needs to be reviewed as the delays in submitting the Vigilance Clearance causes delay in clearance of the proposals.

25. In some of the departments, like; Police and Education, Rural Development Department Selection Grade posts have been shown in the separate class and category. These are non-functional posts and form a percentage of posts in the feeding cadre of functional posts, in which such selection grade is provided. While re-looking at the Recruitment Rules, the selection grade posts should be shown appropriately, so that they are not considered as functional promotions.

26. The departments should constitute Screening Committees for considering officers for grant of selection grade and such proposals need not be placed before the DPC/PSC. Necessary amendments can be made in the Recruitment Rules, where-ever required to exempt the selection grade category of posts from the purview of the DPC/PSC.

27. The advices/recommendations tendered by the Commission need to be followed, and, in case the

Government delays to act as per its advice, the Commission be kept informed along with the reasons thereof. In case of non-acceptance of opinion/advice of the Commission in any case, the Government has to record reasons for non-acceptance of the same.

28. The recruitment rules for services, for which the Commission has conveyed its agreement, need to be notified and no amendment in service rules be made without consulting the Public Service Commission as required under section 124 of the Constitution of the Jammu and Kashmir.

29. The departments need to consult the Commission at the time of making appointments by transfer from one service to another and also at the time of issuing the initial constitution as the same invariably involves the appointments by transfer.

30. The departments need to pursue the court cases pertaining to promotions, recruitment and departmental examinations promptly and file counter/ objections promptly so that the cases are decided on merits.

12 . Profiles of the Hon'ble Members of the Commission

Dr. Farooq Ahmad Lone, Hon'ble Member/ Interim Chairman, J&K PSC.

Born at Anantnag, Dr. Farooq Ahmad Lone originally belongs to Village Khargund, Chowgam of Tehsil Devsar in district Kulgam.

After his initial schooling in the native village schools viz. Government Primary School Khargund and Government High School Chowgam, he graduated from Government Degree College Anantnag in the year 1981 with first Division in English, Botany, Zoology and Chemistry subjects. Thereafter, he joined Botany Department of University of Kashmir for his M.Sc. Degree, which he completed with first class first position in 1983 followed by M.Phil and Ph.D. degrees in 1984 and 1987 respectively.

Dr. Lone started his career in teaching and research as Junior Research Fellow & Senior Research Fellow at the University of Kashmir and Lecturer in Education/Higher Education Departments. He published his research work as a Book titled "Paleoethnobotany: Plants and Ancient Man in Kashmir" which has been published by the Oxford and IBH Publishing Company, New Delhi, and AA Balkema Rotherdam. Netherlands Taylor and Francis Group has recently published an e-book edition of the book in August, 2020. In addition, he has published more than thirty papers in leading National and International journals and Conference proceedings. He has also written

popular articles in science magazines and columns in local newspapers.

He joined the J&K State Science and Technology Department in the year 1992 where he served as Scientific Officer, Deputy Director, Joint Director and Additional Director in the Science & Technology Council until his induction in the J&K Administrative Service (KAS) in the year 2000 followed by the Indian Administrative Service (IAS) in 2014 with 2009 as year of allotment.

As an Administrator, he has served as Deputy Director Information Department (2001-2003), Deputy Director Estates Department (2003-2005), Deputy Director Tourism Department (2005), Administrator Associated Hospitals Srinagar (2005-2006), Chief Executive Officer, Gulmarg Development Authority (2006-2009, with additional charge of Managing Director J&K State Cable Car Corporation in 2008), Joint Director Information Department, Kashmir (2009-2011), Director Agriculture Department Kashmir (2011-2013, with additional charge of Managing Director, J&K State Agro Industries Development Corporation from 2011-2012), Deputy Commissioner Anantnag (2013-2014), Deputy Commissioner Baramulla (2014-15), Deputy Commissioner Srinagar (2015-17, with additional charge of Commissioner, Srinagar Municipal Corporation and Vice Chairman, Srinagar

Development Authority in 2016), Chief Executive Officer, Economic Reconstruction Agency (ERA) with additional charge of Chief Executive Officer, Srinagar Smart City Ltd. (2017-2018), Secretary Social Welfare Department (2018-2019, with additional charge of Administrative Secretary, Cooperatives and Tribal Affairs Departments in 2018) and Secretary General Administration Department with additional charge of Director General, J&K Institute of Management, Public Administration & Rural Development (2019-2020). 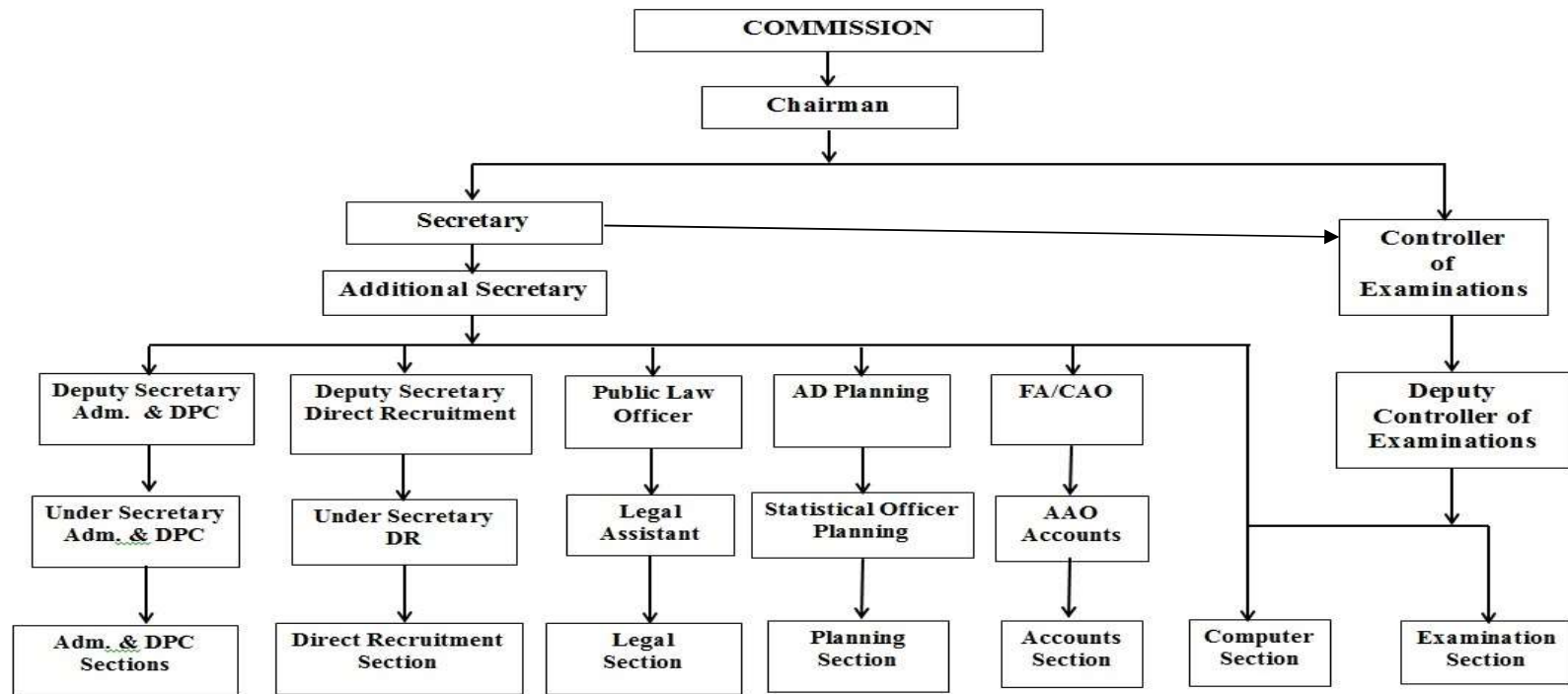
