Whereas, in response to the Notice dated 23.12.2025, Mr. Abdul Majid and Mr. Om Prakash submitted the documents, Mr. Amir Iqbal has failed to submitted the requisite document; and,

Whereas, upon scrutiny of the documents submitted by Mr. Abdul Majid and Mr. Om Prakash, it has been found that the certificates submitted by the said candidates are not valid/not within the cut of date of the advertisement Notification for the post.

Now, therefore, the candidature of all three above mentioned candidates is hereby rejected for the post of Lecturer (Education) in School Department, on the following reasons, mentioned against each:-

01	Amir Iqbal	Not produced the EWS category certificate as per the format prescribed under Reservation rules of J&K UT.

03	Abdul Majeed	The first ST category certificate submitted by the candidate was issued on 08.4.2024, is conditional ( for appointment in posts of Govt. of India). Another ST category certificate produced by him issued on 25.12.2025, is after cut of date.


However, if any of the candidate(s) feels aggrieved with the rejection of his candidature, he may represent before the Appellate Authority of the Commission with evidence in support of his claim within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period is over.
