
Whereas, in response to the Notice dated 24.12.2025, all the above listed candidates submitted the document; and,

Whereas, upon scrutiny of the documents submitted by above mentioned candidates in response to the Notice dated 24.12.2025, it has been found that the category certificates submitted by the above candidates are not valid as on cut of date of the advertisement Notification for the post.

Now, therefore, the candidature of all the above listed candidates is hereby rejected for the post of Lecturer (Economics) in School Department for the reasons mentioned against each:-

S.No.	Name of the candidate	Reasons
1	Humnishen Amin	The validity of the EWS category certificate dated 18-12- 2023 has expired before the cut of date of the advertisement Notification.
2	Parul Sharma	The EWS category certificate submitted by the candidate is as per the Central format and issued after the cut of date.
3	Deep Kumar	The candidate has submitted two EWS category certificates dated 03-01-2023 and 18.12.2025. The validity of the certificate dated 03.01.2023 has expired before the cut of date, and the certificate dated 18.12.2025 is after the cut of date of the advertisement Notification.

However, if any of the candidate(s) feels aggrieved with the rejection of his candidature, he/she may represent before the Appellate Authority of the Commission with evidence in support of his/her claim within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period is over.
