5. Whereas, the Experts have recommended changes in the Provisional Answer Key(s) in respect of the said paper(s);

 Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

- a) The changes recommended by the Experts are hereby adopted and the Final Answer Key(s) are annexed to this notification as Annexure A and Annexure B in respect of **Environmental Science and Psychology**. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the

deleted questions ***shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged***, at the time of calculation/compilation of award sheet before the declaration of the result;

b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.




