Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024/35/2024-01(7383282) dated 12.11.2024 and dated 05.12.2024, referred 50 posts (OM=20, RBA=05, SC=04, ST1=05, ST-2=05, ALC/IB=02, OBC=04 and EWS=05) of Lecturer Zoology in School Education Department to J&K Public Service Commission for selection; and

Whereas, the posts were advertised vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024; and

Whereas, the written test was conducted on 12.10.2025 and the result thereof was declared vide Notification No. PSC/Exam/S/2026/61 dated 01.12.2025. 155 candidates were declared to have provisionally qualified the written examination for viva-voce; and

Whereas, Ms. Rohi Sultan bearing Roll No. 7401992, has filled application form under OM/PHC category for the post; and

Whereas, while scrutinizing of documents, it has been found that the disability certificate is temporary and as such the candidate cannot be considered under the PHC category.

Now therefore, the candidature of Ms. Rohi Sultan bearing Roll No. 7401992 for the post Lecturer (Zoology) in pursuance of Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024, is hereby rejected. However, if she feel aggrieved with the rejection of her candidature, she may represent before the Appellate Authority of the Commission with documentary evidence in support of her claim within 10 days from the date of issuance of this Notice. No claim whatsoever, shall be entertained after the stipulated period is over.
