Whereas, Higher Education Department, vide letter No. HED-GAZ/85/2022-04 dated: 13.04.2022, referred eighteen (18) posts (OM: 08, RBA: 02, SC: 02, EWS: 01, ALC: 01, PSP:01, SLC:01) of Assistant Professor (Computer Application) to the J&K Public Service Commission, for selection; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC (DR-P) of 2023 dated: 01.03.2023, advertised the said posts; *and*,

Whereas, the written test was conducted on 29.08.2024 and the result of the written test was declared vide Notification No. PSC/Exam/S/2024/67 dated: 05.11.2024; *and*,



Whereas, the viva-voce of the candidates was conducted on 25<sup>th</sup> to 27<sup>th</sup> of August, 2025; *and*,

Whereas, the provisional Select List was issued vide notification bearing No. 02-PSC(DR-S) of 2026 dated 07.01.2026 wherein it was stated that the selection is provisional, subject to objections, if any received, within five days; *and*,

Whereas, one representation has been received from Mr. Shyam Sunder Saini wherein he has stated that he authored two books with valid ISBN numbers in the year 2019 and 2020. One Mark only has been given against his two published books. He further states that two books, both duly published with valid ISBN numbers in the year 2019 and 2020, should have been given two marks. However, he has been given only one mark, as such, has requested for reverfication and providing for the full 2 marks instead of one mark;

Whereas, as per records, the subject expert has accepted only one publication viz., Fundamentals of Digital Electronic and not the other one. Further, the assessment/ award of the special attributes is the domain of subject experts and their decision is accepted as final by the Commission.

Now, therefore, the above representation is disposed off, being devoid of any merit and is, hence, rejected.
