Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred **two (02) posts (OM: 01, SC:01) of Lecturer, (Arabic)**, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; **and,**

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; **and,**

Whereas, the result of the written examination was declared vide Notification PSC/Exam/S/2026/12 Dated: 23.01.2026. Six (06) candidates were declared to have qualified for interview provisionally. Out of 06 candidates, 01 candidate namely Ms Ronak Jan bearing Rollno 5100182 in SC category was found in-eligible as she possessed SLC(OBC) category instead of SC category upon verification of documents; **and,**


Whereas, the viva-voce of candidates was conducted on 10.02.2026, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43,1(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

Consequent upon the facts stated here-in-above, **Ajaz Ahmad Ganie S/O Gh Mohammad Ganie R/O 197 Monghama Tral** having secured **65.03** points, is provisionally selected against the available post.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
3. One post of SC category remained vacant due to non-availability of candidate.


