Whereas, the Higher Education Department, vide letter No. HE-Coll/Coord/Appt/AP/2014 dated 25.09.2020 and HED-GAZ/85/2022-04 dated 13.04.2022, referred fifty three (52+1) posts of Physical Training Instructor, in Govt. Degree Colleges, as per the following break-up, to the J&K Public Service Commission, for selection:

Whereas, the said posts were advertised vide Notification No. 08- PSC (DR-P) OF 2023 dated: 01.03.2023. The cut-off date for determination of eligibility was fixed as 31.03.2023; and,

Whereas, the Department, vide their communication No. HED-GAZ/85/2022-04 dated: 13.04.2022, quoted here-in-above, referred three more posts of Physical Training Instructor, in Govt. College of Engineering and Technology, as per the following break-up, to the J&K Public Service Commission:

Whereas, the said posts were advertised vide Notification No. 11- PSC (DR-P) OF 2023 dated: 05.04.2023. The cut-off date for determination of eligibility was fixed as 04.05.2023; and,

Whereas, written test of both notifications was conducted on 17.03.2024. The result of the written test was declared vide Notification No. PSC/Exam/S/2025/17 dated: 25.04.2025, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; and,

Whereas, the viva-voce of candidates was conducted w.e.f 27.10.2025 to 29.10.2025, with the assistance of Experts from outside of UT;

Whereas in the interview notice dated: 15.10.2025. It was clearly stated that the candidature of all the candidates purely provisional. The documents of the candidates will be verified at the time of interview. In case any discrepancy with regard to age and other eligibility conditions is noticed at the time of interview or thereafter, the candidates shall not be allowed to appear in the interview or where the candidate has already appeared in interview, the candidature shall be deemed to have been cancelled ab-initio.

Whereas, one candidate, namely. Mr. Danish Saleem, Roll No. 4300252 applied in both the ibid Notification, but his candidature was considered only against Notification No. 11- PSC (DR-P) OF 2023 dated: 05.04.2023 and was not considered against the Notification No. 08-PSC (DR-P) of 2023 dated 01.03.2023, due to his RBA certificate issued in his favour by Tehsildar Gundna, vide No. JK-REV-SEB/2023/10826 dated 05.04.2023, having been issued after cut off date i.e 31.03.2023 for the said Notification;

Now, therefore, the candidature of Mr. Danish Saleem, Roll No. 4300252 for the post of Physical Training Instructor in Higher Education Department advertised against the claim of Notification No. 08-PSC (DR-P) of 2023 dated 01.03.2023, is hereby rejected.
