Whereas, the Health and Medical Education Department, vide above quoted letters referred 06 posts of Child Psychologist(Ancillary staff), under OM category, one each, in Government Medical College Anantnag, Doda, Kathua, Rajouri, Udampur and Handwara, to the J&K Public Service Commission for selection; and

Whereas, the posts were advertised vide Notification(s) No. 28-PSC(DR-P) of 2023 dated 08.06.2023, No. 30-PSC(DR-P) of 2022 dated 30.12.2022, and 31-PSC(DR-P) of 2022 dated 30.12.2022; and,

Whereas, the written test was conducted on 03.11.2023 and 30 candidates(common) were declared to have qualified the written test vide Notification No. PSC/Exam/S/2024/20 dated 29.04.2024; and,

Whereas, upon scrutiny of documents, it has been found that Mr. Showkat Shafi Bhat(Roll No. 5900009) has experience as Clinical Psychologist from District Hospital Bandipora, as Teaching Assistant in Psychology, Lecturer Psychology, Counselor in Psychology in different degree colleges.

Whereas, the District Hospital Bandipora is not recognized by MCI/NMC, and the experience from different degree colleges in Higher Education Department cannot be considered for the posts in Health & Medical Education Department.

Now, therefore, the candidature of Mr. Showkat Shafi Bhat, is hereby rejected for the post of Child Psychologist(Ancillary Staff), advertised vide Notification(s) No. 28-PSC(DR-P) of 2023 dated 08.06.2023, No. 30-PSC(DR-P) of 2022 dated 30.12.2022, and 31-PSC(DR-P) of 2022 dated 30.12.2022. However, if the candidate feels aggrieved with the rejection of his candidature, he may represent before the Appellate Authority of the Commission with documentary evidence in support of his claim, within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period is over.
