Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred four (04) posts (OM: 02, SC:01, ST-1:01) of Lecturer, (**Persian**), to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; **and**,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 29.09.2025; **and**,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2026/12 dated: 23.01.2026. 19 candidates were declared to have qualified for interview provisionally. Out of (19) candidates, 02 candidates bearing Rollno: **6600069, 6600089** in SC category were found ineligible for not possessing SC category certificate upon verification of documents; **and**,

Whereas, the viva-voce of candidates was conducted on 30.03.2026, with the assistance of Experts from outside of the Union Territory of J&K.


