Whereas, the School Education Department, vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2024, referred four (04) posts (OM: 02, SC:01, ST-1:01) of Lecturer, (**Psychology**), to the J&K Public Service Commission, for selection of suitable candidates; **and**,

Whereas, the J&K Public Service Commission, vide Notification No. 07- PSC (DR-P) of 2024 dated: 09.12.2024, advertised the said posts for inviting applications. The cut-off date for determination of eligibility was fixed as 09.01.2025; **and**,

Whereas, in pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, Rule 31 & 43,1(i) of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date, a written test was conducted on 27.09.2025; **and**,

Whereas, the result of the written examination was declared vide Notification No. PSC/Exam/S/2026/10 dated: 23.01.2026. 20 candidates were declared to have qualified for interview provisionally. Out of (20) candidates, 01 candidate bearing Rollno: **6900804** in Open Merit was found in-eligible for not possessing the requisite/relevant qualification upon verification of documents. In place of the rejected candidate, three candidates having secured equal marks, hence, being next in order of merit, had to be called for interview; **and**,

Whereas, the viva-voce of candidates was conducted on 06.04.2026, with the assistance of Experts from outside of the Union Territory of J&K.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 43,1(i) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.


