Whereas, the Health & Medical Education Department vide letter No. HD-Gaz0/Gen/659/2023-02(e -72545197) dated 09.08.2023, referred 247 posts of Medical Officer (Allopathic) in Health & Medical Education Department, to the J&K Public Service Commission for selection:

Whereas, the posts were notified vide advertisement Notification No. 37-PSC (DR-P) of 2023 dated 10-08-2023; and,

Whereas, the written examination was conducted on 17.03.2024 and the merit list was issued vide Notification No. PSC/Exam/S/2024/10 dated 03.04.2024; and,

Whereas, vide Notice dated 28.06.2024, among others, the applicants Nirmal Kour(Roll No. 3701631) and Poonam Devi(Roll No. 3702068) were directed to report before the Document Verification Committee on 03.07.2024 at the office of J&K Public Service Commission, Jammu or Srinagar. However, they failed to report before the Document Verification Committee either at Jammu or Srinagar office of the Commission; and,

Whereas, vide Notice dated 05.07.2024, the applicants, among others were given final opportunity, to report for Document Verification on 08.07.2024. However, the applicants again failed to report for the document verification on the scheduled date and time; and,

Whereas, vide Notice dated 25.07.2024, the candidature of the applicants, among others was rejected for the post of Medical Officer(Allopathic) in Health & Medical Education Department, advertised vide Notification No. 37-PSC(DR-P) of 2023 dated 10.08.2023 for not having

reported for document verification; and, Whereas, the recommendation was forwarded to the department vide letters dated 05.07.2024, 19.07.2024 and 30.07.2024.

Now, therefore, the representation of the applicants, namely Dr. Nirmal Kour(Roll No. 3701631) and Poonam Devi(Roll No. 3702068), having been considered in light of the order dated 04.07.2025 passed by the Hon'ble Central Administrative Tribunal, Jammu in the matter titled Nirmal Kour & Anr. Vs. UT of J&K & Ors. In O.A. No. 934/2025, has been found devoid of any merit, hence rejected.
