**Subject: Cancellation of candidature and Debarment of candidate on account of resorting to unfair means-regarding.**

**Order NO: 21-(E)PSC/Exam/2026**

**DATED: 08.04.2026**

Whereas, the Jammu and Kashmir Public Service Commission (J&K PSC) had conducted the Written Examination of Combined Competitive Examination (Main)-2024, vide Notification No. 04-PSC (DR-P) of 2024 Dated: - 26.07.2024 2024 w.e.f. 23.07.2025 to 01.08.2025; and

Whereas, a candidate namely Mr. Ajaz Ahmad S/o Mr. Sharief Hussain R/o Umar Colony Sector-D, Malik Market, Channi Rama, Jammu, appeared in the said examination under Roll No. 9022467 at Govt. Girls Higher Secondary School, Kothibagh Srinagar; and

Whereas, as per the report of the Centre Superintendent and Centre Observer the said candidate was found to be in possession of mobile phone and capsule sized Bluetooth earpiece and he was using same during the conduct of examination at Srinagar Govt. Girls Higher Secondary School, Kothibagh Srinagar; and

Whereas, notwithstanding the above, vide No.JKPSC-Exm/188/2025-05 (E-7736603) dated 16.09.2025, a show cause letter was issued to the said candidate to explain his position. The reply to the said show cause letter was submitted by the candidate and was examined in the light of relevant Rules/Regulations; and

Whereas, the said candidate had admitted that he was in possession of the mobile phone during the conduct of Written Examination and accepted that it was an offence for which he is liable for disciplinary proceedings relevant Rules/Regulation; and


Whereas, the case was placed before the unfair Means Committee constituted in terms of Jammu and Kashmir Public Service Commission (Conduct of Examination) rules, 2022 under rule 32. After considering the nature of the offence and evidence brought on record as well as the reply of the show cause notice submitted by the candidate the committee recommended as under:-

***“Mr. Ajaz Ahmad S/o Mr. Sharief Hussain (Roll No. 9022467), declared as ‘failed’ in full Examination of J&K Combined Competitive (Main) Examination-2024. Furthermore, the candidate is disqualified /debarred from appearing in any such examinations to be conducted by the Commission for a minimum of two years.”***

Whereas, the recommendation of the Unfair Means Committee was placed in the 35<sup>th</sup> Meeting of the Commission held on 26.12.2025, which accepted the recommendation of the Unfair means committee and decided as:-

***“Mr. Ajaz Ahmad S/o Sh. Sharief Hussain bearing Roll No. 9022467 has been declared ‘failed’ in full Examination of J&K Combined Competitive (Main) Examination-2024 and is also disqualified/debarred from appearing in any such Examination to be conducted by the Commission for minimum two (02) years.”***

Therefore, in view of the above and as per J&K Public Service Commission (Conduct of Examination) Rules, 2022, the candidature of Mr. Ajaz Ahmad S/o Mr. Sharief Hussain R/o Umar Colony Sector-D, Malik Market, Channi Rama, Jammu, who appeared in the said examination under Roll No. 9022467, is hereby cancelled. The candidate is further disqualified/debarred from appearing in any such examinations to be conducted by the J&K Public Service Commission for a period of two (02) years from the date of incident/examination i.e. 24.07.2025.
