Whereas, Health & Medical Education Department, vide letter No. Me-Gztd/270/2022 dated: 01.11.2022, referred two (02) posts of Maternity & Child Welfare Officer (Ancillary Staff) one each in GMC Handwara & Udhampur under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the posts were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, again the Health & Medical Education Department, vide letter No, Me-Gztd/246/2022 dated: 05.12.2022, referred two (02) posts of Maternity & Child Welfare Officer cum Lecturer/Assistant Professor one each in GMC Doda & Rajouri under under Open Category, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the post was advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, again the Health & Medical Education Department, vide letter No, Me-Gztd/246/2022-02 dated: 26.07.2023, referred one (01) post of Maternity & Child Welfare Officer cum Lecturer/ Assistant Professor in GMC Kathua, under Open Category, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the post was advertised vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023. The cut-off date for determination of eligibility was fixed as 19.08.2023; **and,**

Whereas, written test was conducted on 07.10.2025. The result of the written test was declared vide Notification No. PSC/Exam/S/2025/53 dated 12.11.2025, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, the candidates were called for interview as per the breakup given below.


