Whereas, Health & Medical Education Department, vide letter No. MeGztd/270/2022 dated: 01.11.2022, referred **two (02)** posts of Child Psychologist (Ancillary Staff), one each in GMC Handwara & Udhampur under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the posts were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, again the Health & Medical Education Department, vide letter No, MeGztd/246/2022 dated: 05.12.2022, referred **two (02)** posts of Child Psychologist one each in GMC Anantnag & Rajouri under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the posts were advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, the Health & Medical Education Department vide letter No. ME Gztd/21/2022 dated: 07.07.2022, had also referred **two (02)** posts of Child Psychologist one each in GMC Doda & Kathua under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the posts were advertised vide Notification No. 28-PSC (DR-P) of 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023; **and,**

Whereas, written test was conducted on 03.11.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2024/20 dated 29.04.2024, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**
