Subject: Filling up of the posts of Lecturer Education in School Education Department. Disposal of representation thereof.

Whereas, the School Education Department vide letters No: Edu-Gen/35/2024-01(7383282) Dated: 12.11.2024 and dated: 05.12.2024, referred 48 posts (OM =19, RBA =05, SC= 04, ST-1= 05, ST-2= 05, ALC/IB =02, OBC= 04, EWS= 04) of Lecturer Education in School Education Department to J&K Public Service Commission for selection; and,

Whereas, the posts were advertised, vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2025; and,

Whereas, the written test was conducted on 27.09.2025 and result thereof was declared vide Notification No: Notification No. PSC/Exam/S/2025/59 dated 01.12.2025. 152 candidates were declared to have provisionally qualified the examination for viva-voce; and,

Whereas, the provisional Select List for the post of Lecturer, Education, in School Education Department was notified vide Notification No. 13-PSC(DR-S) of 2026 dated 24.02.2026, with a stipulation that the selection is provisional and objections, if any, may be submitted to the commission within five days; and

Whereas, in response to the ibid notification, the following three candidates have submitted representations/objections against the Provisional Select List:-


1. Bharti Sharma.

Whereas, the objections raised in the representations and their consideration is given here-in-under:

1	Bharti Sharma	<i>She has alleged that Ms. Lovleen Kour Awal D/o Jasbir Singh Awal, has secured Rank 1 under the ST2 category. However, as per the information available in the result notification, her address is mentioned as H. No. 237, Sector 2. Govina Nagar. Talab Tillo, Jammu</i>	<i>From the documents uploaded by the candidate at the time of filing of application form, the Domicile certificate, PSP certificate provides address of Tehsil Haveli Poonch. However, in her form she has in both Permanent mailing address and Correspondence mailing address given Talab Tillo Jammu.</i>

		<i>It is understood that the ST2 category is specifically reserved for candidates belonging to the Rajouri-Poonch district. The mentioned residential address appears to fall outside the notified ST2 eligible area. Hence may take a view.</i>

Despite successful participation in the recruitment process & appearing in the interview process & also meeting the requisite eligibility for the said post under PWD category, i noticed that the PWD category has been excluded from the selection in the provisional selection list.</i>	<i>Against the 01 post earmarked for PHC candidate in Education discipline, Mr. Shabir Ahmad Malik has been selected under RBA/PHC category. Since, the reservation is horizontal, one candidate having sub-category of PHC has got selected, no further selection can be made under PHC category.</i>									

Now, therefore, the above representations are disposed off, being devoid of any merit and are, hence, rejected.
