**Sub: Filling up of the post of Lecturer-I, Automobile Engineering in Skill Development Department-Rejection of candidature thereof.**

**Notice**

**Dated: 11.05.2026**

Whereas vide Notice Dated: 23.07.2025, candidature of six candidates was rejected on the grounds that they did not possess relevant qualification prescribed for the post;

Whereas, out of six candidates, three candidates including Mr. Naveed Shafiq Shah filed appeals which were duly placed before the Appellate Authority for its decision and rest of the candidates chose not to appeal;

Whereas, Appellate Authority in its decision opined, operative part of which is reproduced as under:

**“...the Appellate Authority is of the opinion that the matter should be referred to the concerned department for placing the same before the Equivalence Committee constituted for the purpose to determine whether the degrees possessed by the appellants are equivalent to the degrees in automobile engineering.”**

Whereas, the issue was taken with indenting department viz., Skill Development Department and Skill Development Department vide its communication Dated: 11.03.2026 has clarified that only those candidates possessing a Degree of B. Tech in Mechanical Engineering (Automobile) with atleast 55% marks are eligible for the post of Lecturer-I (Automobile Engineering);

Whereas, on further examination of the documents of Mr. Naveed Shafiq Shah, it has come to fore that the candidate has submitted RBA certificate issued on 20.01.2023 i.e. after cutoff date given in the advertisement notice i.e., 23.02.2022;

Now, therefore, the candidature of the above named candidate is hereby rejected on the count given hereinabove. If the candidate feels aggrieved with the rejection of his/her candidature, he/she may represent before the Appellate Authority of the Commission with evidence in support of his / her claim within 10 days from the date of issuance of this Notice.

No claim whatsoever shall be entertained after the stipulated period.
