Subject: Filling up of the post of Lecturer Urdu in School Education Department- Disposal of representation thereof.

Whereas, the School Education Department vide letter No. Edu-Gen/35/2024-01 (7383282) dated 12.11.2024 and 05.12.2025, among others, referred 36 posts (OM=15, RBA 03, SC=03, ST-1=04, ST-2=04, ALC/IB=02, OBC=02, EWS=03) of Lecturer Urdu in School Education Department, to the J&K Public Service Commission for selection; and,

Whereas, these posts was advertised, vide Notification No. 07-PSC (DR-P) of 2024 dated 09.12.2024, and,

Whereas, the written test was conducted on 05.10.2025, and result thereof was declared vide Notification No. PSC/Exam/S/ 2026/18 dated 06.02.2026. The viva-voce of the candidates was conducted from 15.04.2026 to 21.04.2026; and,

Whereas, the Provisional Select List for the post of Lecturer, Urdu, in School Education Department notified vide Notification No. 30-PSC(DR-S) of 2026 dated 21.04.2026, with stipulation allowing the objections; and,

Whereas, in response, the representation/complaint has been received from the following candidates:-

1. Some aspirants of Lecturer Urdu (Anonymous).
2. Mr. Abdul Kyoum.

Whereas, the objection raised in representation/complaints and their consideration is given here-under:-

S.No.	Name of the representee	Objection	Decision
1	Aspirant of Lecturer	Objection against certain selected candidates regarding the award of higher scores in the final selection list.	The Objection /complaint is anonymous.

2	Mr. Abdul Kyoum	<p>The candidate has stated that a candidate namely, Abdul Qayoom S/o Mohd Rashid, R/o Kankote, P.O. Bandi Chechian, Tehsil Haveli, District Poonch has been selected under the ALC/IB category. However, there is a strong apprehension regarding the eligibility of the said candidate for ALC/IB category. As per my knowledge, the annual income of the candidate's family is above 8 lakh, which raises serious doubt about the validity of the certificate and eligibility criteria claimed under the said reserved category.</p> <p>He has requested to kindly verify the ALC/IB certificate and all supporting documents submitted by the candidate, including income and residence criteria, and conduct a thorough and impartial inquiry to ensure fairness and transparency in the selection process</p>	<p>The ALC/IB certificate produced by the candidate in the Commission is issued by Competent Authority and is valid with respect to cut-off date of the Notification.</p>
