Whereas, the Health & Medical Education Department, vide letter No. Me-Gztd/246/2022 dated 05.12.2022, referred **one(01)** post of Assistant Professor(Medical Officer Health cum Lecturer) RTHC in **GMC Doda**, under Open Category, to the J&K Public Service Commission, for selection of suitable candidate; and,

Whereas, the said post was advertised vide Notification No. **31-PSC(DR-P) of 2022 dated 30.12.2022**. The cut-off date for determination of eligibility was fixed as 31.01.2023, and,

Whereas, again Health Education Department vide letter No.ME-Gztd/56/2022 dated 06.04.2022 referred one (1) post of Assistant Professor Medical Officer Health cum Lecturer UTHC in GMC Doda. Under open category. to the J&K Public Service Commission for selection of suitable candidate; and,

Whereas, the post was advertised vide Notification No. 28-PSC(DR-P) OF 2023 dated 08.06.2023. The cut-off date for determination of eligibility was fixed as 30.06.2023; and,

Whereas, the Health Education Department, again vide letter No ME-Gztd/246/2022-02 dated 26.07.2023 referred four (04) posts of Assistant Professor, Medical Officer Health Cum lecturer)under Open category to the J&K Public Service Commission for selection of suitable candidate with the following break-up:-

Whereas, these posts were advertised vide notification No 35-PSC(DR-P)2023 dated 03.08.2023.The cut of determination of eligibility was fixed as 19.08.2023; and,

Whereas, the written test was conducted on 08.10.2025.The result of the written test was conducted on08.10.2025.The result of the written test was

declared vide Notification NO PSC/Exam/S/2025/53 dated 12.11.2025, in pursuance of rule 42 of J&K Public service commission (conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules 2021 as amended up to date, the candidates were called for interview as per the breakup given below:

Whereas, the viva-voce of candidates was conducted on 12.02.2026, with the assistance of Experts from outside UT; and,

Whereas, on the basis of the performance in the written test, interview and other related attributes in pursuance of Rule 44(ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates, who appeared in the interview a provisional Select List was issued vide Notification No. 12-PSC(DR-S) of 2026 dated 12.02.2026, for the post of Assistant Professor (Medical Officer Health cum Lecturer) RTHC in GMC Baramulla, Doda & Rajouri and Assistant Professor (Medical Officer Health cum Lecturer) UTHC in GMC Baramulla, Doda & Kathua in Health & Medical Education Department, with advise to the candidates to furnish their objections, if any, to the Commission within five days of issuance of ibid notification:


Whereas, in response to ibid Notification, Dr. Najma Akhtar vide her representation dated 13.02.2026 has submitted that during verification of documents she had delivered 04 presentations. However, the marks of presentation do not appear in aggregated score in 12-PSC(DR-S) of 2026 dated 12.02.2026 for the post of Assistant Professor UTHC in GMC, Kathua and has submitted following documents as proof:-

- i) Certification of presentation
- ii) Certificate of participation of conference.
- iii) Power point presented in conference.
- iv) Page of Soureir/e mail of OP.

Whereas, Dr. Najma Akhtar, in her representation has further submitted that, the candidates who borrowed soureir from her, during verification of documents, have been awarded marks and has requested for inclusion of presentation marks in final aggregated scores of AP, UTHC in GMC-Kathua; and,

Whereas, the representation dated 13.02.2026 submitted by the Applicant has been examined in the Commission, for the post of Medical Officer Health cum Lecturer/Assistant Professor(UTHC) in GMC, Kathua and 04 presentations submitted by her at the time of interview have not been accepted by the Experts. The assessment/award of the special attributes is the domain of subject experts and their decision is accepted as final by the Commission.

Now, therefore, the representation dated 13.02.2026 submitted by the applicant has been examined and found devoid of any merit, and is hereby rejected.
