In pursuance of Rule 42 of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date read with Rule 31 and 44 of the J&K Public Service Commission (Business and Procedure) Rules, 2021 candidates forming **Annexure-A, B, C, D, E and F** to this notification are hereby declared to have qualified for the Oral Test/Viva-Voce for the posts of Assistant Professor in the disciplines of **Neuro Surgery, Urology, Medical Oncology and Tutor** in SKIMS, in Health & Medical Education Department on the basis of their performance in the Written Tests which was held on **17.05.2026**. The documents of the candidates will be verified at the time of interview and in case any discrepancy with regard to age/qualification/experience and other eligibility conditions is noticed at the time of interview or thereafter, the candidate shall not be allowed to appear in the interview or where the candidate has already appeared in the interview, the candidature shall be deemed to have been cancelled *ab-initio*.
- iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.

- iv. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
